#### STATEMENT OF LEGISLATIVE INTENT

Senator Carona submitted the following statement of legislative intent for **SB 149** from the 77th Legislature, Regular Session:

Statement of Legislative Intent Senate Bill 149 77th Legislature, Regular Session

Mr. President and Members.

I have asked for the opportunity to speak today to make you aware of an issue and to seek an expression of legislative intent from this body.

In 2001, the 77th Legislature passed a bill that I authored, SB 149. The bill addressed the Tuition Equalization Grant program and its purpose was to tighten the language of the TEG statute regarding institutions approved to participate in the program.

Since the TEG's inception, institutions whose students could receive TEGs were required to achieve the same accreditation as public institutions of higher education, which is to successfully complete the rigorous review of the Commission on Colleges of the Southern Association of Colleges and Schools. Where SACS accreditation was not appropriate, other accreditors of Texas public institutions, such as the American Bar Association and the Liaison Committee on Medical Education, were acceptable alternatives

In the months before the 77th Legislature convened, the Coordinating Board began to "recognize" other accrediting agencies including all of the regional accrediting bodies across the country, few of which match the thoroughness of SACS accreditation. Coordinating Board recognition allowed institutions that were not SACS accredited to award degrees in Texas without securing a certificate of authority to grant degrees from the Coordinating Board. When I learned this, I became concerned that at some future time the Coordinating Board might accept an institution accredited by one of its recognized entities for participation in TEG, rather than requiring the tougher SACS accreditation. I carried SB 149 to prevent that.

SB 149 amended Section 61.222 of the Education Code to specify that institutions whose students participate in TEG must have the same accreditation as Texas public institutions. That was the current practice, and the Coordinating Board staff with whom I worked on SB 149 understood that we were codifying the existing practice. We did this to ensure that any student receiving a TEG would receive a higher education that would meet the same standards that a student at our public institutions would receive.

Years have passed and the staff with whom I worked are no longer at the Coordinating Board. I understand that the Coordinating Board is beginning to interpret Section 61.222, as I amended it, more broadly than I intended and more broadly than I explained it to this body when I passed it.

Members, I seek your assistance today in allowing me to place my remarks in the *Senate Journal* as a statement of legislative intent that: No institution should be approved to participate in the TEG program unless it has been accredited by an accrediting agency that accredits public institutions of higher education in Texas.
