VOTE RECONSIDERED ON COMMITTEE SUBSTITUTE HOUSE BILL 2

Senator Williams moved to reconsider the vote by which **CSHB 2** was finally passed:

CSHB 2, Relating to the allocation of certain revenue from franchise taxes, motor vehicle sales and use taxes, and taxes on cigarettes and other tobacco products to school district property tax relief and public education.

The motion prevailed by the following vote: Yeas 20, Nays 10.

REMARKS ORDERED PRINTED

On motion of Senator Shapiro and by unanimous consent, the exchange between Senators Williams and Shapiro regarding **CSHB 2** was ordered reduced to writing and printed in the *Senate Journal* as follows:

Senator Shapiro: I know you referenced this many times, but I just want to say as simple as I think you intended for it to be, the issue is very clear, and the problem that we have is, under the current law, what we call an enrichment tier is not what, under the new law, we're going to call a local enrichment tier, is that correct?

Senator Williams: That is correct, Senator Shapiro.

Senator Shapiro: So when we look at this verbiage that has been drafted for you, as all of us have, we look at that enrichment tier or enrichment tax, and we make an assumption it's the new third tier, and it's not.

Senator Williams: I understand why people are confused, and I had a similar question, as did you.

Senator Shapiro: Great. And so your intent, as you have said numerous times, your intent, then, is that, not go to equalization at the local enrichment tier, but in the basic tier, which is what we call tier one and tier two, to raise the guaranteed yield, to raise the basic allotment.

Senator Williams: And that's correct, Senator Shapiro. And if you look at the section of the Education Code where we pulled these terms of art from, it is the basic tier language that we have.

Senator Shapiro: Perfect.

Senator Williams: That's clearly what my purpose is, and I appreciate your questions.

Senator Shapiro: Excellent. Thank you.

CONSIDERATION POSTPONED

On motion of Senator Williams, further consideration of **CSHB 2** was temporarily postponed to a time certain of 5:30 p.m. today.

Question — Shall **CSHB 2** as amended be finally passed?

Senator Williams offered the following amendment to the bill:

Floor Amendment No. 1 on Third Reading

Amend **CSHB 2** on third reading in SECTION 1 of the bill as follows:

- (1) Strike added Section 403.109(c)(2), Government Code (page 1, lines 43-48), and substitute the following:
- (2) one-third of the money appropriated from the fund may be appropriated only for the purpose of increasing the level of equalization of school district enrichment tax effort to the extent that limits reliance by school districts on local property tax effort and decreases the enrichment tax rates of districts.
- (2) In added Section 403.109(d), Government Code (page 1, lines 56-57), strike "to the Texas Education Agency".

The amendment to **CSHB 2** was read and was adopted by the following vote: Yeas 20, Nays 10.

POINT OF ORDER

Senator Barrientos raised a point of order that **CSHB 2** was in violation of Section 30, Article III, Texas Constitution, stating that the bill had more than one subject.

POINT OF ORDER RULING

The President stated that the point of order was respectfully overruled.

On motion of Senator Williams and by unanimous consent, the caption was again amended to conform to the body of the bill as amended.

CSHB 2 as again amended was again finally passed by the following vote: Yeas 20, Nays 10.

Senate Resolution 143

WHEREAS, The Senate of the State of Texas honors and commemorates the life of William Max Hale, who died March 17, 2006, at the age of 70; and

WHEREAS, Bill grew up in the Texas Panhandle; he was a passionate civil rights advocate, and he worked at the Mobilization for Youth program with Michael Schwerner in New York and marched with Dr. Martin Luther King, Jr., in the South; and

WHEREAS, Early in his career, Bill served as director and area coordinator of the Volunteers in Service to America program; he was head of the Fort Worth Human Relations Commission and was instrumental in the passage of the Texas Fair Housing Act and the Texas Commission on Human Rights Act by the Texas Legislature; and

WHEREAS, Bill was the first executive director of the Texas Human Rights Commission, a position he held for 17 years; under his direction, the agency was able to obtain the first successful enforcement of fair housing laws against the Ku Klux Klan; and

WHEREAS, Bill received numerous national and international honors for his work and was recognized by the Texas Senate and the House of Representatives for his contributions to the state; and

WHEREAS, He served as chair of the Austin Human Rights Commission and as president of the International Association of Official Human Rights Agencies; and

WHEREAS, A man of courage, strength, and compassion, Bill gave generously to others, and his wisdom, warmth, and valued counsel will not be forgotten by those who knew him; and

WHEREAS, He was a devoted husband, father, and grandfather, and he leaves behind memories that will be cherished forever by his family and countless friends; now, therefore, be it

RESOLVED, That the Senate of the State of Texas, 79th Legislature, 3rd Called Session, hereby extend sincere condolences to the bereaved family of William Max Hale: his wife, Karen; his son, Mathis Hale; his daughter, Lisa Coody; and his grandchildren, Britton, Paige, and Jace; and, be it further
