# COMMITTEE SUBSTITUTE HOUSE BILL 5 ON THIRD READING

Senator Armbrister moved to suspend the regular order of business to take up for consideration **CSHB 5** at this time on its third reading and final passage:

**CSHB 5**, Relating to increases in the taxes on cigarettes and other tobacco products.

#### REASON FOR VOTE

Senator Zaffirini submitted the following reason for vote on **CSHB 5**:

I cast a "No" vote on the motion to suspend the rules to take up and consider **CSHB 5**, relating to increases in the taxes on cigarettes and other tobacco products. I did so because the bill restricts funds generated from the increased tax on tobacco products to reducing property taxes without providing adequate flexibility to fund health and human services priorities. Admittedly regressive, the tobacco tax increase should have been used to a greater extent for programs that benefit those who will pay for it. Instead, **CSHB 5** will burden low-income smokers for the benefit of property owners.
