# OFFICIAL MEMORANDUM STATE OF TEXAS OFFICE OF THE GOVERNOR

TO THE SENATE AND HOUSE OF REPRESENTATIVES OF THE SEVENTY-NINTH TEXAS LEGISLATURE, REGULAR SESSION:

There is no greater priority than protecting those who cannot help themselves, especially those who are in the dawn of their lives or the twilight of their years and who are at risk of abuse, neglect and manipulation. During the past year, the Health and Human Services Commission has conducted a systemic review of how the state cares for these citizens in need. I issued an executive order creating a new Division of Investigations to focus investigators' time on the critical job of receiving, reviewing, and investigating reports of abuse and neglect. I have called upon you to appropriate \$253 million in new general revenue for Child Protective Services during the next biennium to hire more than 800 new investigators and other clerical and support staff,

to provide \$5,000 retention bonuses for investigators, and to provide a 5 percent across-the-board pay raise to other workers. Likewise, I have called upon you to hire 144 new caseworkers for Adult Protective Services and to institute comprehensive reforms including transferring guardianship services to the Department of Aging and Disability Services.

THEREFORE, I, RICK PERRY, Governor of the State of Texas, pursuant to Article III, Section 5, of the Texas Constitution and by means of this special message, do hereby submit the following emergency matter for immediate consideration to the 79th Legislature, now convened:

Legislation that provides for comprehensive reform and additional funding for Child Protective Services and Adult Protective Services.

# OFFICIAL MEMORANDUM STATE OF TEXAS OFFICE OF THE GOVERNOR

TO THE SENATE AND HOUSE OF REPRESENTATIVES OF THE SEVENTY-NINTH TEXAS LEGISLATURE, REGULAR SESSION:

Education is the foundation for the economic and cultural future of the state of Texas. We must maintain an equitable system of school finance that ensures student performance and accountability are the primary goals. Educational excellence requires that the state provide resources to reward higher levels of student performance. Likewise, the state's system of accountability must include new measures of financial accountability and transparency in budgeting. Any changes in revenue structures must stimulate job creation and provide a healthy climate in which business can operate and expand. Local property taxes must be cut and controlled to ensure that Texans are not burdened by excessive property tax rates without a vote.

THEREFORE, I, RICK PERRY, Governor of the State of Texas, pursuant to Article III, Section 5, of the Texas Constitution and by means of this special message, do hereby submit the following emergency matter for immediate consideration to the 79th Legislature, now convened:

Legislation that provides for comprehensive reform of the public education system by creating incentives to improve student performance and teacher compensation, by affirming greater accountability and transparency in school budgeting, and by supporting these goals with a finance system that encourages and stimulates a healthy job creation climate.
