REMARKS ORDERED PRINTED

On motion of Senator Whitmire and by unanimous consent, the opening and closing remarks by the President regarding Law Enforcement Day were ordered reduced to writing and printed in the *Senate Journal*.

Members, if I could have your attention. We're going to be getting our series of bills today; as all of you know, this is Law Enforcement Day. The only bills we're taking up today are bills to support our law enforcement in the State of Texas. I want it to be our first day that we can take regular bills on the floor that are not emergency items to focus on law enforcement. And it came to me last July, when I was in Dallas for the funerals and the services of the fallen officers, that we wanted to make a strong statement of support, not just in a gesture but in actually passing legislations that will impact a family and impact the officers, help protect them with our vest,

with property tax relief for spouses if they lose their husband or wife or first responder. This is for police, fire, EMS, any first responder. So, I want to thank all the Senators who have joined with us. We have four bills and an SJR today, and we're going to focus on making sure that every man and woman who wears a uniform of the State of Texas, who represents the great people of Texas, hears loud and clear the Texas Senate put them first when this session began, because they deserve to be first.

Senator Huffines offered the following amendment to the bill:

Floor Amendment No. 1

Amend SB 15 (senate committee printing) in SECTION 1 of the bill as follows:

- (1) In added Section 11.134, Tax Code, strike Subsection (b) of the section (page 1, lines 40-47) and substitute the following:
- (b) The surviving spouse of a first responder who is killed or fatally injured in the line of duty is entitled to an exemption from taxation of the total appraised value of the surviving spouse's residence homestead if the surviving spouse:
- (1) is an eligible survivor for purposes of Chapter 615, Government Code, as determined by the Employees Retirement System of Texas under that chapter; and
 - (2) has not remarried since the death of the first responder.
- (c) The exemption provided by this section applies regardless of the date of the first responder's death if the surviving spouse otherwise meets the qualifications of this section.
- (2) In added Section 11.134(c), Tax Code (page 1, line 48), strike "(c)" and substitute "(d)".

The amendment to SB 15 was read and was adopted by a viva voce vote.

Senator West: Senator Huffines, would you ki— for purpose of legislative intent, would you kindly address the issue that if, if a spouse, be it a male or female, gets remarried, would, whether or not they would be eligible for this exemption?

Senator Huffines: Yes, thank you, Mr. West, Senator West, for qual—asking me that question to qua—understand this amendment more. If the spouse of the surviving officer killed or first responder killed in line of duty remarries, they are no longer qualified for the exemption.

Senator West: And there are several other statutes like surviving spouse of military—

Senator Huffines: Yes, Sir, this-

Senator West: –persons.

Senator Huffines: -yes, Sir, this tracks exactly the language from the 83rd legislative session when we gave the same exemption for surviving military.

Senator West: Thank you.

- (c) A vest or plate purchased with a grant received under this section must comply with a National Institute of Justice standard for rifle protection.

(4) In added Section 772.0073(d), Government Code (page 1, line 42), strike "deployment and allocation of vests to its officers" and substitute the following:

<u>:</u>

- (1) deployment and allocation of vests or plates to its officers; and
- (2) usage of vests or plates by its officers
- (5) In added Section 773.0073(e), Government Code (page 1, lines 46 through 47), strike "including the price of each vest and the number of vests purchased" and substitute the following:

ballistic plates, and plate carriers, including the price of each item and the number of each type of item purchased

(6) In added Section 773.0073(f)(3), Government Code (page 1, line 56), strike "the number of vests" and substitute "as reported under Subsection (e), the number of vests, plates, and carriers".
