SB 3 Bettencourt Sponsor: Geren

Relating to the amount of the total revenue exemption for the franchise tax and the exclusion of certain taxable entities from the requirement to file a franchise tax report.

(President in Chair) HOUSE JOINT RESOLUTION 2

On motion of Senator Bettencourt and by unanimous consent, Senate Rule 8.02 and Senate Rule 10.01 were suspended to take up for consideration **HJR 2** at this time.

The President laid before the Senate the following resolution:

HJR 2, Proposing a constitutional amendment to authorize the legislature to establish a temporary limit on the maximum appraised value of real property other than a residence homestead for ad valorem tax purposes; to increase the amount of the exemption from ad valorem taxation by a school district applicable to residence homesteads; to adjust the amount of the limitation on school district ad valorem taxes

imposed on the residence homesteads of the elderly or disabled to reflect increases in certain exemption amounts; to except certain appropriations to pay for ad valorem tax relief from the constitutional limitation on the rate of growth of appropriations; and to authorize the legislature to provide for a four-year term of office for a member of the governing body of certain appraisal entities.

BETTENCOURT

The resolution was read.

Senator Gutierrez offered the following amendment to the resolution:

Floor Amendment No. 1

Amend HJR 2 (house committee report) as follows:

- (1) On page 7, line 15, between "amounts;" and "to", insert "to provide supplemental payments to full-time classroom teachers in school districts;".
- (2) Add the following appropriately numbered SECTION to the resolution and renumber subsequent SECTIONS of the resolution appropriately:

SECTION _____. Article VII, Texas Constitution, is amended by adding Section 21 to read as follows:

- Sec. 21. (a) A school district is entitled to state funding for the 2023-2024 and 2024-2025 school years for each full-time classroom teacher employed by the district in the applicable school year as follows:
- (1) if the district has 20,000 or more students enrolled in the preceding school year, \$2,000 per full-time classroom teacher; and
- (2) if the district has fewer than 20,000 students enrolled in the preceding school year, \$6,000 per full-time classroom teacher.
- (b) A school district shall use money received under this section to provide a supplemental payment to each full-time classroom teacher in the district for the applicable school year in the amount received per full-time classroom teacher under Subsection (a) of this section.
- (c) For each school year for which this section provides for supplemental payments for full-time classroom teachers, there is appropriated from the general revenue fund to the Texas Education Agency the amount necessary to fund the supplemental payments provided by this section. The agency shall distribute the money to school districts in the amount required to fund the supplemental payments.

(d) This section expires September 1, 2025.

WHEREAS, The son of Charlie Martinez Jr. and Mary Louise Martinez, Mario Martinez was born in Bay City on June 2, 1954; he grew up with three siblings, Cecilia, Julia, and Charlie; after graduating from Southwest Texas State University with a bachelor's degree in criminal justice, he began working as a legislative aide to State Representative Tom Uher and rose to become chief of staff; he went on to serve as governmental affairs director for the Texas State Troopers Association for more than a decade; and

WHEREAS, Mr. Martinez married the love of his life, Louann, in 1994, and they became the parents of two treasured daughters, Avery and McKenna; the couple founded the consulting firm Martinez & Associates in 1996, and until his passing, Mr. Martinez represented major industries and law enforcement entities, providing expertise regarding a number of challenging issues; a loyal and diligent advocate for his clients, he distinguished himself through his integrity, professionalism, and deep expertise in the inner workings of government; his big heart, engaging personality, and wonderful sense of humor brought him numerous close friendships, and he was a kind mentor to many; and

WHEREAS, Above all, Mr. Martinez was dedicated to his family; he encouraged his daughters to follow their dreams while instilling the importance of education, a strong work ethic, and good character; in addition, he shared with them his love of hunting, fishing, and adopting stray animals; he also enjoyed spending time in Rockport on his boat; and

WHEREAS, Deeply caring, Mario Martinez sought to use his skill and influence not only for the benefit of his clients, but also for the betterment of Texas, and he will be greatly missed by all who were privileged to share in the richness of his life; now, therefore, be it
