#### **PROCEEDINGS**

#### FIRST DAY

(Monday, October 9, 2023)

In obedience to the Proclamation of the Honorable Greg Abbott, Governor of the State of Texas, the Senate met in the Senate Chamber of the State Capitol at Austin, Texas, on the 9th day of October, 2023, at 1:00 p.m. and was called to order by the Honorable Dan Patrick, Lieutenant Governor and President of the Senate.

The President directed the Secretary of the Senate to call the roll of the Senate.

The roll was called and the following Senators were present: Alvarado, Bettencourt, Birdwell, Blanco, Campbell, Creighton, Eckhardt, Flores, Gutierrez, Hall, Hancock, Hinojosa, Huffman, Hughes, Johnson, King, Kolkhorst, LaMantia, Menéndez, Middleton, Miles, Nichols, Parker, Paxton, Perry, Schwertner, Sparks, Springer, West, Whitmire, Zaffirini.

The President announced that a quorum of the Senate was present.

Pastor Matthew Paul, Summit Worship Center, Austin, offered the invocation as follows:

O sovereign God, God most holy, the source of our strength, You call these leaders in this special session today to serve the public, promote justice, and establish peace in our land. I lift before You all who serve the State of Texas through this body, its Senators, and its staff represented here today. Give to those whom we entrust with authority, discernment and understanding, a spirit of knowledge and of resolve. As they gather today to make decisions that affect Your people, I pray You would give them ears to hear and a heart to understand the needs of those in which they serve. You remind us that a house which is divided cannot stand. So, I ask that You will give to them a spirit of unity to work together, to put differences aside for the good of those You have entrusted them to govern. Grace them with Your presence, not only today but as long as they live, and may what is done here today lay the foundation for a better future tomorrow. I pray this through Your holy name. Amen.

## SENATE RULE 8.02 SUSPENDED (Referral to Committee)

On motion of Senator King and by unanimous consent, Senate Rule 8.02 was suspended to take up and consider **SR 2** immediately.

#### **SENATE RESOLUTION 2**

Senator King offered the following resolution:

WHEREAS, Hamas was founded with the stated goal of destroying the State of Israel and has been designated by the United States as a Foreign Terrorist Organization; and

WHEREAS, The Hamas terrorist organization launched a brutal, highly organized, and unprecedented attack upon Israel and its citizens in the early morning hours of October 7, 2023; and

WHEREAS, In its attack, Hamas has killed hundreds of innocent civilians and taken hundreds of Israeli children, women, elderly, and infirm civilians hostage; and

WHEREAS, In its attack, Hamas has fired thousands of rockets against Israeli population centers in an attempt to kill untold numbers of innocent civilians; and

WHEREAS, The level of logistical sophistication demonstrated in this Hamas terrorism operation indicates its receipt of support and funding from foreign state sponsors of terror, namely Iran; and

WHEREAS, The timing of this Hamas terrorism operation to coincide with the observance of the Jewish Sabbath and celebration of the Sukkoth holiday demonstrates the intent to maximize civilian casualties; and

WHEREAS, Hamas continues to brazenly locate elements of its terrorist infrastructure in civilian population centers using civilians as human shields; now, therefore, be it

RESOLVED, That the Senate of the 88th Texas Legislature, 3rd Called Session, hereby

- 1. Reaffirm its support and unwavering commitment to the welfare, security, and survival of the State of Israel:
- 2. Recognize Israel's right to act decisively and unilaterally in self-defense to protect its citizens;
- 3. Express its support for Israel's right to pursue without interference or condemnation the elimination of Hamas until Hamas is permanently neutralized and public safety is assured;
- 4. Convey its most heartfelt condolences to all Israeli victims as well as their families and communities;
- 5. Call upon Texas law enforcement to remain vigilant in protecting Israeli Americans, Jewish Americans, and all supporters of Israel from acts of crime and unlawful discrimination that tend to manifest at such times;
- 6. Encourage all other American states to likewise condemn Hamas as well as any official body that refuses to recognize Israel's right to act decisively in self-defense to protect its citizens; and
- 7. Call upon the United States to provide all assistance as may be required to support Israel in its defense against Hamas and all other terrorist organizations.

#### PROCLAMATION BY THE GOVERNOR

The following Proclamation by the Governor was read and was filed with the Secretary of the Senate:

# PROCLAMATION BY THE GOVERNOR OF THE STATE OF TEXAS

#### TO ALL TO WHOM THESE PRESENTS SHALL COME:

I, GREG ABBOTT, Governor of the State of Texas, by the authority vested in me by Article III, Sections 5 and 40, and Article IV, Section 8 of the Texas Constitution, do hereby call extraordinary session #3 of the 88th Legislature, to convene in the City of Austin, commencing at 1 p.m. on Monday, October 9, 2023, for the following purposes:

To consider and act upon the following:

Legislation providing education savings accounts for all Texas schoolchildren.

Legislation to do more to reduce illegal immigration by creating a criminal offense for illegal entry into this state from a foreign nation and authorizing all licensed peace officers to remove illegal immigrants from Texas.

Legislation to impede illegal entry into Texas by increasing the penalties for certain criminal conduct involving the smuggling of persons or the operation of a stash house.

Legislation to impede illegal entry into Texas by providing more funding for the construction, operation, and maintenance of border barrier infrastructure.

Legislation concerning public safety, security, environmental quality, and property ownership in areas like the Colony Ridge development in Liberty County, Texas.

Legislation prohibiting COVID-19 vaccine mandates by private employers.

The Secretary of State will take notice of this action and will notify the members of the legislature of my action.
