SENATE RESOLUTION 161

Senator Alvarado offered the following resolution:

WHEREAS, Members of the Houston East End Chamber of Commerce are gathering in Austin on February 15, 2023, to celebrate East End Day at the State Capitol; and

WHEREAS, Predating the founding of the city of Houston, the East End can trace its origins to the 1820s, when New York entrepreneur John Richardson Harris established Harrisburg at the intersection of Brays and Buffalo Bayous; after briefly serving as the capital of the Republic of Texas, the town was annexed by Houston in 1926; today, the East End encompasses more than 234,000 people and 7,700 businesses, and it remains a location of great importance as the proud home of the Port of Houston, one of the nation's foremost ports for international trade and one of the largest port facilities in the world; and

WHEREAS, The Houston East End Chamber of Commerce was founded in 1991 to promote economic expansion and investment in the area; guided by this central goal, the chamber hosts a wide range of programs, such as business luncheons, business-to-business seminars, and other events that encourage new commercial ventures, foster good will, and support existing businesses, and in recent years, it has provided webinars and other resources to help business leaders meet the challenges of the COVID-19 pandemic; moreover, the group created the Strategic Vision for the East End in 2006, and the chamber and its partners have since made outstanding progress, establishing an Economic Development Division in 2009 and the East End Street Fest in 2013; the East End serves as the commercial center of the city and the hub of its transportation systems, and an investment exceeding half a billion dollars is bringing light rail through the heart of the district as well as street beautification projects; and

WHEREAS, Dedicated to equipping the next generation with the knowledge and skills necessary to succeed, the chamber foundation has awarded more than \$500,000 in scholarships over the past 17 years; in addition, the chamber launched an annual Education Symposium and helped organize Port of Houston Maritime Academies at Stephen F. Austin and Jack Yates High Schools as well as a National Engineering Academy at Chávez High School; and

WHEREAS, The Houston East End Chamber of Commerce has remained steadfast in its mission to promote economic vitality by establishing strong connections throughout the community, and it is a pleasure to recognize the organization for its myriad contributions to the East End; now, therefore, be it

RESOLVED, That the Senate of the 88th Texas Legislature hereby recognize February 15, 2023, as Houston East End Chamber of Commerce East End Day at the State Capitol and extend a warm welcome to the visiting delegation.

Senator Nichols offered the following resolution:

WHEREAS, The Senate of the State of Texas is pleased to recognize Stephen F. Austin State University on the occasion of its centennial celebration; and

WHEREAS, Stephen F. Austin State University had its beginnings when the Texas Legislature authorized a new institution of higher education to be located in far East Texas and to be named in honor of the Father of Texas, Stephen F. Austin; and

WHEREAS, In 1917, the State Board of Regents selected Nacogdoches as the location of the new college because of its rich heritage as the oldest town in Texas; the citizens of Nacogdoches chose the homestead of Thomas J. Rusk, which had been owned by Sam Houston, as the site for the new college, as both Rusk and Houston had served as the original two United States Senators from Texas; and

WHEREAS, Stephen F. Austin State Teachers College opened its doors to 270 students in 1923; today, the university enrolls more than 11,300 students and provides a vital educational, economic, and cultural resource in the region; the heart of higher education in deep East Texas, the university offers more than 120 areas of study and countless opportunities for student athletes to participate in Division I intercollegiate sports, bringing recognition and a sense of pride to the Nacogdoches area; and

WHEREAS, Named the top rural-serving institution of its size in Texas by the Alliance for Research on Regional Colleges, Stephen F. Austin State University now comprises six colleges; its living alumni number 115,000 graduates who have been educated by this fine university to be true citizens of the world; and

WHEREAS, Stephen F. Austin State University has for 100 years been dedicated to creating opportunities for students to access transformative higher education; alumni represent their university in their communities and workplaces, and they contribute to the economic, civic, and cultural vitality of Texas; it is truly fitting that the university receive special recognition on the occasion of this important milestone in the school's history; now, therefore, be it

RESOLVED, That the Senate of the State of Texas, 88th Legislature, hereby recognize 2023 as the Centennial Year of Stephen F. Austin State University and extend a warm welcome to the visiting delegation; and, be it further

RESOLVED, That a copy of this Resolution be prepared for them as an expression of esteem from the Texas Senate.

WHEREAS, Dr. Ott earned his bachelor's and master's degrees at Angelo State University and his doctorate at The University of Texas at Austin, and he began his career as a coach, teacher, and principal in Round Rock and Anson; after serving as director of statewide initiatives for the Texas Education Agency and director of literacy initiatives for the UT System, he was deputy superintendent in Copperas Cove and Killeen before joining Temple ISD in 2012 as assistant superintendent of curriculum and instruction; during his nearly six-year tenure in this position, he helped to greatly improve the district's ratings with the state accountability system; and

WHEREAS, Since becoming Temple's superintendent in April 2018, Dr. Ott has demonstrated remarkable drive, energy, and initiative; his excellent working relationship with the board of trustees helped the board win recognition as 2019-2020 Region 12 School Board of the Year, and under his leadership, the district has received national awards for two years in a row for fiscal transparency and stewardship from the Government Finance Officers Association and ASBO International; and

WHEREAS, Dr. Ott also demonstrated remarkable leadership during the COVID-19 pandemic, and he oversaw the successful passage of a \$164.8 million bond package for the district in 2022; he presents an annual overview of the district to civic groups and other stakeholders across the community, and he sends out a monthly digital newsletter, *Ott's Outlook*, to more than 5,000 subscribers; and

WHEREAS, In addition to his professional responsibilities, Dr. Ott finds time to give back to his community as a board member of Workforce Solutions of Central Texas, the Temple Economic Development Corporation, the Temple Chamber of Commerce, McLane Children's Medical Center, the Temple Education Foundation, and the State Advisory Council of the Texas Music Educators Association, among other groups; in all his endeavors, he benefits from the love and support of his wife, Nicole, and his two daughters, Jordan and Tatum; and

WHEREAS, Through his unwavering dedication to area students and staff, Bobby Ott has led the way in fostering a supportive and challenging educational environment, and he has made valuable contributions to advancing public education in the Lone Star State; now, therefore, be it

RESOLVED, That the Senate of the 88th Texas Legislature hereby congratulate Dr. Bobby Ott on being recognized as TASB's 2022 Superintendent of the Year and extend to him sincere best wishes for continued success in his important work; and, be it further
