**FIFTY-NINTH DAY**

(Tuesday, May 23, 2023)

The Senate met at 11:49 p.m. pursuant to adjournment and was called to order by the President.

HOUSE BILL 1588 ON SECOND READING**

The President laid before the Senate **CSHB 1588** sponsored by Senator Middleton on its second reading. The bill had been read second time, amended, and further consideration postponed to a time certain of 9:00 p.m. today:

**CSHB 1588**, Relating to funding of excess losses and operating expenses of the Texas Windstorm Insurance Association; authorizing an assessment; authorizing a surcharge.

**HB 5202**, Relating to a central database containing information about offenders who have committed certain violent offenses.

**COMMITTEE SUBSTITUTE  
HOUSE BILL 7 ON SECOND READING**

Senator Birdwell moved to suspend the regular order of business to take up for consideration **CSHB 7** at this time on its second reading:

**CSHB 7**, Relating to measures to address public safety threats in this state presented by transnational criminal activity, including by establishing a Texas Border Force, and to compensate persons affected by those threats; increasing criminal penalties; creating criminal offenses.

Senator Blanco offered the following amendment to the bill:

**Floor Amendment No. 1**

Amend **CSHB 7** (senate committee report) in SECTION 1.02 of the bill, in added Section 411.0285, Government Code (page 2, between lines 44 and 45), by inserting the following:

(d) Funds used to purchase technology and equipment described by Subsection (a) are considered funds expended for border security for purposes of reporting requirements in the General Appropriations Act, and the Legislative Budget Board may prescribe the form and manner of reporting the relevant budgeted and expended amounts and performance indicator results.

The amendment to **CSHB 7** was read and was adopted by a viva voce vote.

All Members are deemed to have voted "Yea" on the adoption of Floor Amendment No. 1.

Senator Birdwell offered the following amendment to the bill:

**Floor Amendment No. 2**

Amend **CSHB 7** (senate committee report) in SECTION 1.02 of the bill, in added Section 411.0283(3), Government Code (page 1, line 60), by striking "conducting border security operations" and substituting "in border security operations led by the border force".

The amendment to **CSHB 7** was read and was adopted by a viva voce vote.

All Members are deemed to have voted "Yea" on the adoption of Floor Amendment No. 2.

Senator Birdwell offered the following amendment to the bill:

### **Floor Amendment No. 3**

Amend **CSHB 7** (senate committee report) as follows:

(1) In SECTION 1.02 of the bill, in the heading to added Section 411.0286, Government Code (page 2, line 45), after "PATROL", add "OR MILITARY".

(2) In SECTION 1.02 of the bill, in added Section 411.0286, Government Code (page 2, line 49), between "Protection" and "for", insert "or a member of the armed forces of the United States".

(3) Strike SECTION 1.03 of the bill (page 3, line 4, through page 3, line 28) and renumber the SECTIONS of ARTICLE 1 of the bill accordingly.

The amendment to **CSHB 7** was read and was adopted by a viva voce vote.

All Members are deemed to have voted "Yea" on the adoption of Floor Amendment No. 3.

Senator King offered the following amendment to the bill:

### **Floor Amendment No. 4**

Amend **CSHB 7** (senate committee report) as follows:

(1) In SECTION 1.02 of the bill, in added Section 411.0283, Government Code (page 1, line 53), between "OPERATIONS." And "The border force", insert "(a)".

(2) In SECTION 1.02 of the bill, immediately following added Section 411.0283, Government Code (page 2, between lines 12 and 13), insert the following:  
Only commissioned officers of the border force may carry out the duties assigned to a commissioned peace officer. An employee of the border force who is not a commissioned peace officer may:

(1) Act in support of a commissioned peace officer; and

(2) Engage in support and infrastructure operations of the border force.

The amendment to **CSHB 7** was read and was adopted by a viva voce vote.

All Members are deemed to have voted "Yea" on the adoption of Floor Amendment No. 4.

Senator Birdwell offered the following amendment to the bill:

### **Floor Amendment No. 5**

Amend **CSHB 7** (senate committee report) by:

(1) Striking ARTICLE 4 of the bill, foreign terrorist organizations (page 5, line 22 through page 10, line 30) ;

(2) By striking ARTICLE 5 of the bill, landowner compensation for property damage caused by certain criminal activities (page 10, line 31 through page 12, line 1) ;

(3) Renumber the ARTICLES of the bill and the SECTIONS of those ARTICLES as appropriate.

The amendment to **CSHB 7** was read and was adopted by a viva voce vote.

All Members are deemed to have voted "Yea" on the adoption of Floor Amendment No. 5.

Senator Huffman offered the following amendment to the bill:

**Floor Amendment No. 6**

Amend **CSHB 7** (senate committee report) by adding the following appropriately numbered ARTICLE to the bill and renumbering the ARTICLES and SECTIONS of the bill accordingly:

ARTICLE . BORDER REGION COURT PROGRAM

SECTION .01. Chapter 72, Government Code, is amended by adding Subchapter H to read as follows:

SUBCHAPTER H. BORDER PROTECTION COURT GRANT PROGRAM

Sec. 72.201. DEFINITIONS. In this subchapter:

(1) "Border-related offense" means an offense:

(A) associated with or involving:

(i) a person unlawfully entering or attempting to enter this state by crossing the Texas-Mexico border at any place other than at a port of entry;

(ii) the smuggling of individuals or contraband across the Texas-Mexico border; or

(iii) an operative of a transnational cartel;

(B) similar to an offense described by Paragraph (A) that the office by rule defines as a border-related offense for purposes of this subchapter; or

(C) for which the office has determined prosecutions have significantly increased as a result of Operation Lone Star.

(2) "Border region" has the meaning assigned by Section 772.0071.

Sec. 72.202. GRANT PROGRAM. (a) From money appropriated for that purpose, the office shall establish and administer a grant program to support the operation of courts in the border region with the adjudication of border-related offenses.

(b) In addition to other funds appropriated by the legislature and for purposes of administering and funding the grant program, the office may:

(1) seek and apply for any available federal funds; and

(2) solicit and accept gifts, grants, and donations from any other source, public or private, as necessary to ensure resources are available to achieve the purpose described by Subsection (a).

(c) The grants awarded under this subchapter may be used for the reimbursement of costs associated with the operation of a court, including the:

(1) salary of a visiting judge appointed under Chapter 74;

(2) salary and benefits of an associate judge, court coordinator, court administrator, court reporter, and court interpreter;

(3) salary and benefits of district and county clerk staff;

(4) travel costs and other expenses incurred by court personnel and judges in the performance of their duties;

(5) cost of equipment necessary for personnel dedicated to the processing and adjudicating of border-related offenses;

(6) fees and related expenses for the appointment of counsel to represent an indigent defendant under Chapter 26, Code of Criminal Procedure, or the costs to operate a public defender's office or managed assigned counsel program under that chapter, as those fees and expenses relate to the adjudication of border-related offenses; or

(7) salary, benefits, and related expenses of prosecution personnel.

Sec. 72.203. RULES. (a) The office shall adopt rules for the administration and operation of the grant program established under this subchapter.

(b) In adopting the rules, the office shall:

(1) conduct a study of the data collected for this purpose or otherwise available on crime, arrests, detentions, and convictions to identify offenses for which prosecutions have increased as a result of Operation Lone Star; and

(2) solicit from governmental officials, community leaders, and other interested persons in the border region information necessary to identify the courts of the region needing financial assistance.

(c) The rules must include:

(1) administrative provisions for grants awarded under this subchapter, including:

(A) eligibility criteria for grant applicants, including criteria to limit eligibility to those applicants experiencing an increase in caseloads;

(B) grant application procedures;

(C) guidelines relating to grant amounts;

(D) procedures for evaluating grant applications; and

(E) procedures for monitoring the use of grants;

(2) methods for tracking the effectiveness of grants and the efficiency of the applicants receiving grants; and

(3) procedures for reporting caseload data at least annually, including caseload data necessary to update the study described by Section 72.2055.

Sec. 72.204. GRANT AMOUNTS. The amount of a grant awarded under this subchapter may not exceed the amount set by the General Appropriations Act.

Sec. 72.205. REPORTING REQUIREMENTS FOR GRANT RECIPIENTS. The recipient of a grant awarded under this subchapter shall submit to the office an annual report on the grant money spent during the year covered by the report and the purposes for which that money was spent.

Sec. 72.2055. ANNUAL REPORT BY OFFICE. Annually, the office shall update the study conducted under Section 72.203(b)(1) using caseload data required to be reported under the rules adopted under Section 72.203(c).

Sec. 72.206. ADMINISTRATIVE COSTS. Unless otherwise provided by the appropriation, the office may use a reasonable amount, not to exceed five percent, of any general revenue appropriated for purposes of this subchapter to pay the costs of administering the grant program.

SECTION .02. As soon as practicable after the effective date of this article, the Office of Court Administration of the Texas Judicial System shall with respect to Subchapter H, Chapter 72, Government Code, as added by this article:

(1) adopt rules as necessary to implement the subchapter; and

(2) establish the grant program required by the subchapter.

The amendment to **CSHB 7** was read and was adopted by a viva voce vote.

All Members are deemed to have voted "Yea" on the adoption of Floor Amendment No. 6.

Senator Birdwell offered the following amendment to the bill:

**Floor Amendment No. 7**

Amend **CSHB 7** (senate committee report) as follows:

(1) In SECTION 7.01 of the bill, in added Section 421.112(2), Government Code (page 13, line 14), following the underlined semicolon, strike "and".

(2) In SECTION 7.01 of the bill, in added Section 421.112, Government Code, strike added Subdivision (3) (page 13, lines 15 through 18) and substitute the following:

(3) the payment of staff salaries and benefits and the payment of operational expenses related to providing law enforcement services, emergency services, detention services, and court administration services;

(4) the construction and maintenance of temporary border security infrastructure, including temporary walls, barriers, fences, wires, trenches, surveillance technology, or other improvements, designed or adapted to surveil or impede the movement of persons or objects across the Texas-Mexico border at locations other than ports of entry; and

(5) any other activity that the office determines necessary to address offenses that are committed in the border region or are related to transnational criminal activity.

(3) In SECTION 7.01 of the bill, following added Section 421.112, Government Code (page 13, between lines 18 and 19), insert the following:

Sec. 421.113. ADMINISTRATIVE COSTS. Unless otherwise provided by the appropriation, the office may use a reasonable amount, not to exceed five percent, of any funds appropriated for purposes of this subchapter to pay the costs of administering this subchapter.

The amendment to **CSHB 7** was read and was adopted by a viva voce vote.

All Members are deemed to have voted "Yea" on the adoption of Floor Amendment No. 7.

Senator Birdwell offered the following amendment to the bill:

**Floor Amendment No. 8**

Amend **CSHB 7** (senate committee report) in SECTION 8.01 of the bill, in added Section 794.001, Government Code (page 13, line 25), by striking "shall" and substituting "may".

The amendment to **CSHB 7** was read and was adopted by a viva voce vote.

All Members are deemed to have voted "Yea" on the adoption of Floor Amendment No. 8.

Senator Menéndez offered the following amendment to the bill:

**Floor Amendment No. 9**

Amend **CSHB 7** (senate committee report) as follows:

(1) In SECTION 1.02 of the bill, in the heading to added Section 411.0287, Government Code (page 2, line 54), between "TRAINING" and the underlined period, insert "REQUIRED".

(2) In SECTION 1.02 of the bill, immediately after added Section 411.0287, Government Code (page 2, between lines 63 and 64), insert the following:

(c) Any officer or employee who performs duties in connection with a border security operation of the border force shall complete a training on federal immigration law with respect to a person's right to seek asylum and appropriate procedures for affording a person that right.

Amend **CSHB 7** (senate committee report) in SECTION 1.02 of the bill, immediately after added Section 411.0289, Government Code (page 3, between lines 3 and 4), by inserting the following:

Sec. 411.0290. INTERPRETER SERVICES REQUIRED FOR BORDER SECURITY OPERATIONS. The border force shall ensure that interpreter services are available to officers and employees of the border force during any border security operation, including during the apprehension of a person suspected of violating 8 U.S.C. Section 1325(a). The border force may employ interpreters or contract for interpreter services as necessary to ensure immediate availability of the services during a border security operation.

(2) Add the following appropriately numbered SECTION to ARTICLE 2 of the bill and renumber subsequent SECTIONS of that ARTICLE accordingly:

SECTION 2. \_\_. Chapter 39, Penal Code, is amended by adding Section 39.08 to read as follows:

Sec. 39.08. COERCION TO COMMIT IMPROPER ENTRY FROM FOREIGN NATION. (a) A person who is a peace officer or member of the Texas Border Force under Subchapter B-2, Chapter 411, Government Code, commits an offense if the person knowingly coerces a person to engage in conduct constituting an offense under Section 38.20.

(b) An offense under this section is a Class A misdemeanor.
