- (5) In SECTION 3 of the bill, in amended Section 25.025(a)(28), Tax Code (page 5, line 55), following "Texas Juvenile Justice Department;" strike "and" and substitute "[and]".
- (6) In SECTION 3 of the bill, in amended Section 25.025(a)(29), Tax Code (page 5, line 57), between "Department of Family and Protective Services" and the period, insert the following: ; and
- (30) a current or former employee of a public defender's office as defined by Article 26.044(a), Code of Criminal Procedure
