## **SENATE RESOLUTION 671**

Senator Bernsen offered the following resolution:

WHEREAS, The Senate of the State of Texas takes pride in paying tribute to the life of Captain Jesse Billingsley and in recognizing the role he played in our state's history on April 21, 1836; and

WHEREAS, Born October 10, 1810, in Warren County, Tennessee, Jesse Billingsley moved to Missouri in 1817 and later settled near David Crockett in Gibson County, Tennessee, in 1828; and

WHEREAS, On May 5, 1835, he arrived in Bastrop County and settled in Cedar Creek, Texas; he joined the Texas Army under the command of General Edward Burleson and became captain of the Mina Volunteers; and

WHEREAS, Upon hearing that his friend and role model Davy Crockett had been killed at the Alamo, Captain Billingsley reorganized the Mina Volunteers and is credited with being the first man to proclaim the famous battle cry, "Remember the Alamo!"; and

WHEREAS, As commander of Company C, Captain Billingsley ignored orders to countermarch and courageously proceeded to San Jacinto to assist Colonel Sidney Sherman and his men who were outnumbered by Santa Anna's army; and

WHEREAS, Captain Billingsley's men suffered severe casualties from the blast of the enemy's cannon fire, and Captain Billingsley sustained a wound to his left hand, leaving it crippled for life; however, he and his regiment saved the lives of many of Colonel Sherman's men and helped them to be victorious in that famous battle on April 21, 1836; and

WHEREAS, Captain Billingsley was honored for his valor by artist William H. Huddle who placed Captain Billingsley behind Santa Anna in his painting of the historic moment of "The Surrender of Santa Anna"; and

WHEREAS, After the Battle of San Jacinto, Captain Billingsley represented Bastrop County in the First and Second Congress and the Fifth and Eighth legislatures of Texas; he then sacrificed his public career by taking a stand against secession from the Union and by becoming an advocate for the literacy of slaves; and

WHEREAS, In 1874, Captain Billingsley stepped forward to insist that the name of a black soldier, Maxlin "Mack" Smith be inscribed on the San Jacinto honor role after his name had been omitted from the bronze plaque listing those who fought in the Battle of San Jacinto; and

WHEREAS, Captain Billingsley died quietly on October 1, 1880, and was buried in his front yard in McDade, Texas, beside his faithful white horse, Gopher; his body was exhumed under the direction of L. W. Kemp in 1929 and was reinterred in the State Cemetery in Austin near his fellow patriot Stephen F. Austin, "the Father of Texas"; and

WHEREAS, Captain Billingsley's great-great-grandson is Randy Billingsley, who is visiting the Capitol on April 21, 1999, and is joining other descendants of Captain Billingsley's men in paying tribute on San Jacinto Day to the Battle of San Jacinto and to Captain Jesse Billingsley; now, therefore, be it

RESOLVED, That the Senate of the State of Texas, 76th Legislature, hereby honor the memory of Captain Jesse Billingsley and pay tribute to all Texans who participated in the Battle of San Jacinto; and, be it further

RESOLVED, That a copy of this Resolution be prepared for Randy Billingsley as an expression of esteem for Captain Billingsley from the Texas Senate.

The resolution was read.

**CSSB 5,** Relating to the authorization of certain franchise tax incentives promoting economic development.

The bill was read second time.

On page 2, beginning on line 14 replace subsection (2) with the following subsection (2):

- (2) the total amount of credits applied against the tax under this chapter and the amount of unused credits including:
- (A) the total amount of franchise tax due by corporations claiming a credit under this subchapter before and after the application of the credit;
- (B) the average percentage reduction in franchise tax due by corporations claiming a credit under this subchapter;
- (C) the percentage of tax credits that were awarded to corporations with less than 100 employees; and
- (D) the two-digit standard industrial classification of corporations claiming a credit under this subchapter.
- On page 4, beginning on line 43, replace subsection (1) with the following subsection (1):
- (1) the total number of jobs created by corporations that claim a credit under this subchapter and the average and median annual wage of those jobs;
- On page 4, beginning on line 46, replace subsection (2) with the following subsection (2):
- (2) the total amount of credits applied against the tax under this chapter and the amount of unused credits including:
- (A) the total amount of franchise tax due by corporations claiming a credit under this subchapter before and after the application of the credit;
- (B) the average percentage reduction in franchise tax due by corporations claiming a credit under this subchapter; and
- (C) the percentage of tax credits that were awarded to corporations with less than 100 employees.
- On page 4, beginning on line 48, replace subsection (3) with the following subsection (3):
- (3) a breakdown of the two-digit standard industrial classification of businesses claiming a credit under this subchapter.
- On page 6, beginning on line 41, replace subsection (1) with the following subsection (1):
- (1) the total amount of qualified capital investments made by corporations that claim a credit under this subchapter and the average and median wages paid by those corporations;
- On page 6, beginning on line 43, replace subsection (2) with the following subsection (2):
- (2) the total amount of credits applied against the tax under this chapter and the amount of unused credits including:
- (A) the total amount of franchise tax due by corporations claiming a credit under this subchapter before and after the application of the credit;
- (B) the average percentage reduction in franchise tax due by corporations claiming a credit under this subchapter;
- (C) the percentage of tax credits that were awarded to corporations with less than 100 employees; and
- (D) the two-digit standard industrial classification of corporations claiming a credit under this subchapter.

The amendment was read and was adopted by a viva voce vote.

Senator Ogden offered the following amendment to the bill:

#### Floor Amendment No. 2

Amend **CSSB 5** as follows:

- 1. In Section 2 of the bill, Sec. 171.751 (page 2, line 49) insert a new subsection (1) to read as follows and renumber the subsequent subsections appropriately.
- (1) "Agricultural processing" means an establishment primarily engaged in activities described in categories 2011-2099, 2211, 2231, or 3111-3199 of the 1987 Standard Industrial Classification Manual published by the federal Office of Management and Budget.
- 2. In Section 2 of the bill, Sec. 171.751(7) (page 3, line 12), insert "agricultural processing," in between "in" and "central".
- 3. Amend Section 2 of the bill, Sec. 171.751(8)(a) (page 3, line 15 through line 17), to read as follows:
  - (8) "Qualifying job" means a new permanent full-time job that:

### (A) is located in:

- (i) a strategic investment area; or
- (ii) a county with a population of less than 250,000, if the job is created by a business primarily engaged in agricultural processing;
- 4. In Section 2 of the bill, Section 171.752(b) (page 3, line 51) in between "area" and "." insert ", if applicable".
- 5. In Section 3 of the bill, Sec. 171.801(1) (page 5, line 10) insert "Agricultural processing," before the term "Central administrative offices,".
- 6. In Section 3 of the bill, Section 171.801(3) (page 5, line 19), in between "area" and "and" insert ", or first placed in service in a county with a population of less than 250,000 by a corporation primarily engaged in agricultural processing,".
- 7. In Section 3 of the bill, Section 171.802(c) (page 5, line 46) in between "area" and "." insert ", if applicable".

The amendment was read.

Senator Sibley moved to table Floor Amendment No. 2.

## (2) "Strategic investment area" means:

- (A) a county within this state with above state average unemployment and below state average per capita income; or
- (B) an area that, on or before January 1, 1999, is a federally designated urban enterprise community or an urban enhanced supplemental enterprise community.
- (2) In SECTION 1, in Section 171.722(b), Tax Code, strike "county" and substitute "strategic investment area".
- (3) In SECTION 2, in Section 171.752(b), Tax Code, strike "county" and substitute "strategic investment area".
- (4) In SECTION 3, in Section 171.802(c), Tax Code, strike "county" and substitute "strategic investment area".

The amendment was read and was adopted by a viva voce vote.

On motion of Senator Sibley and by unanimous consent, the caption was amended to conform to the body of the bill as amended.

The bill as amended was passed to engrossment by a viva voce vote.

## COMMITTEE SUBSTITUTE SENATE BILL 1251 ON SECOND READING

On motion of Senator West and by unanimous consent, the regular order of business was suspended to take up for consideration at this time on its second reading and passage to engrossment:

**CSSB 1251,** Relating to discontinuance of basic local telecommunications service.

The bill was read second time.

Senator West offered the following amendment to the bill:

#### Floor Amendment No. 1

Amend CSSB 1251 as follows:

- (1) In Section 55.012(b), Utilities Code, as added by SECTION 1 of the bill (Committee report, page 1, line 22), strike "long distance service" and substitute "long distance service or any other service".
- (2) Strike Section 55.012(c), Utilities Code, as added by SECTION 1 of the bill (Committee report, page 1, lines 27 and 28), and substitute:
- (c) Notwithstanding Subsection (a), the commission shall adopt and implement rules, not later than January 1, 2000, to prevent customer abuse of the protections afforded by this section. The rules must include:
- (1) provisions requiring a provider of basic local telecommunications service to offer and implement, at the request and expense of a long distance service provider, toll blocking capability to limit a customer's ability to incur additional charges for long distance services after nonpayment for long distance services; and
- (2) provisions regarding fraudulent activity in response to which a provider may discontinue a residential customer's basic local telecommunications service.
- (d) Notwithstanding any other provision of this title, the commission has all jurisdiction necessary to establish a maximum price that an incumbent local exchange company may charge a long distance service provider to initiate the toll blocking capability required to be offered under the rules adopted under Subsection (c). The maximum price established under this subsection shall be observed by all providers of basic local telecommunications service in the incumbent local exchange company's certificated service area. Notwithstanding Sections 52.102 and 52.152, the commission has all jurisdiction necessary to enforce this section.

The amendment was read and was adopted by a viva voce vote.

On motion of Senator West and by unanimous consent, the caption was amended to conform to the body of the bill as amended.

The bill as amended was passed to engrossment by a viva voce vote.
