WHEREAS, A group of proud Texans is visiting Austin on January 29, 2007, to celebrate the many fine amenities of Rockwall County; and

WHEREAS, Established in 1873, Rockwall County was formed from parts of Nacogdoches, Henderson, and Kaufman Counties; the area takes its name from an extensive, largely subterranean rock formation discovered in the mid-19th century by farmers digging a well; and

WHEREAS, The county seat, also named Rockwall, recently celebrated its 150th anniversary; Rockwall, along with the town of Heath, was founded on the National Road of the Republic of Texas, a major route used by settlers that ran from the Dallas area to the Red River; today, the city of Rockwall's Historic Preservation Advisory Board, the "Old Town" Rockwall Neighborhood Association, and the Rockwall county Historical Foundation direct their efforts toward preserving the notable history of the region for future generations; and
