(Wednesday, January 31, 2007)

WHEREAS, Maverick County was named for Samuel Augustus Maverick in 1856, and its county seat, Eagle Pass, is located on the border between Mexico and Texas; originally named El Paso del Aguila because of the frequent flights of Mexican eagles over the area, the county seat was settled during the middle of the 19th century and has a unique history as a gateway to Texas from Mexico; and

WHEREAS, A favorite of tourists from across the state, Eagle Pass and Maverick County are home to several historically significant sites, including Fort Duncan Park and San Juan Plaza; outdoor recreational activities abound at Maverick County Lake, and nearby Piedras Negras offers residents and tourists alike the opportunity to experience the charm of Mexico firsthand; and
