WHEREAS, Many proud residents of Mansfield are visiting Austin to celebrate the distinctive attributes and achievements of their community during Mansfield Day at the State Capitol; and

WHEREAS, Located in the Cross Timbers country of North Central Texas, south of Arlington, the settlement was first established by pioneers in the 1840s; in the late 1850s, R. S. Man and Julian Feild built a gristmill in the area, at the crossroads that later became the center of the town, which was named for the two men; and

WHEREAS, Mr. Feild soon added a general store across the street from the mill and became the town's postmaster in 1860; during the Civil War, the Man and Feild gristmill supplied meal and flour to fighting soldiers, and it later did the same for those at United States Army outposts and Indian reservations in Texas and New

Mexico; though incorporated in 1909, the town remained a farming community until the suburban expansion of the Dallas/Fort Worth area brought many new residents; and

WHEREAS, Today, the city's more than 60,000 residents can enjoy 240 acres of parks and a quality of life reflected in the town's inclusion on *Money* magazine's 2012 list of the top places to live in the United States; and

WHEREAS, This charming town is an outstanding place in which to live, work, and raise a family, and its citizens may indeed take great pride in their heritage and ongoing achievements; now, therefore, be it

**Floor Amendment No. 1**

Amend **SB 197**, (senate committee printing) in SECTION 1 of the bill, in added Section 102.005(a), Health and Safety Code (Committee Printing page 1, line 27), between "funding" and the period insert "with the exception of patent royalties and license revenues realized as a result of projects undertaken with money awarded under Subchapter E".

The amendment to **SB 197** was read and was adopted without objection.

All Members are deemed to have voted "Yea" on the adoption of Floor Amendment No. 1.

Senator Watson offered the following amendment to the bill:

**Floor Amendment No. 2**

Amend **SB 197**, (senate committee printing) as follows:

(1) In SECTION 1 of the bill, in added Section 102.005 (b) (1), Health and Safety Code (Committee Printing page 1, lines 30-31), strike "before September 1, 2021" and substitute "after issuance of the \$3 billion in general obligation bonds authorized by Article III, Section 67 of the Texas Constitution".

(2) In SECTION 1 of the bill, in added Section 102.005 (b) (2), Health and Safety Code (Committee Printing page 1, lines 33-34), strike "on and after September 1, 2021" and substitute "after issuance of the \$3 billion in general obligation bonds authorized by Article III, Section 67 of the Texas Constitution".

(3) In SECTION 1 of the bill, in added Section 102.005 (b) (3), Health and Safety Code, (Committee Printing page 1, line 36), strike "until September 1, 2021"

(4) In SECTION 1 of the bill, in added Section 102.005 (b) (3), Health and Safety Code, (Committee Printing page 1, line 37) strike "by that date" and insert the following "when the last of the \$3 billion in general obligation bonds authorized by Article III, Section 67 of the Texas Constitution is used to reimburse grant awardees for allowable expenditures pursuant to institute award contract terms".

The amendment to **SB 197** was read and was adopted without objection.

All Members are deemed to have voted "Yea" on the adoption of Floor Amendment No. 2.

On motion of Senator Schwertner and by unanimous consent, the caption was amended to conform to the body of the bill as amended.

**SB 197** as amended was passed to engrossment by a viva voce vote.

SENATE BILL 11 ON SECOND READING**

Senator Birdwell moved to suspend the regular order of business to take up for consideration **CSSB 11** at this time on its second reading:

**CSSB 11**, Relating to the carrying of handguns on the campuses of and certain other locations associated with institutions of higher education.

Senator Huffman offered the following amendment to the bill:

**Floor Amendment No. 1**

Amend **CSSB 11** (senate committee report) as follows:

- (1) Strike SECTION 2 of the bill (page 2, lines 10-23).
- (2) Strike SECTION 5 of the bill (page 3, lines 65-69).
- (3) Add the following appropriately numbered SECTIONS to the bill:

SECTION \_\_\_\_\_. Section 46.035, Penal Code, is amended by amending Subsections (g), (h), and (j) and adding Subsections (a-1) and (l) to read as follows:

(a-1) Notwithstanding Subsection (a), a license holder commits an offense if the license holder carries a partially or wholly visible handgun, regardless of whether the handgun is holstered, on or about the license holder's person under the authority of Subchapter H, Chapter 411, Government Code, and intentionally or knowingly displays the handgun in plain view of another person:

(1) on the premises of an institution of higher education or private or independent institution of higher education; or

(2) on any public or private driveway, street, sidewalk or walkway, parking lot, parking garage, or other parking area of an institution of higher education or private or independent institution of higher education.

(g) An offense under Subsection (a), (a-1), (b), (c), (d), or (e) is a Class A misdemeanor, unless the offense is committed under Subsection (b)(1) or (b)(3), in which event the offense is a felony of the third degree.

(h) It is a defense to prosecution under Subsection (a) or (a-1) that the actor, at the time of the commission of the offense, displayed the handgun under circumstances in which the actor would have been justified in the use of force or deadly force under Chapter 9.

(j) Subsections (a), (a-1), and (b)(1) do not apply to a historical reenactment performed in compliance with the rules of the Texas Alcoholic Beverage Commission.

(l) Subsection (b)(2) does not apply on the premises where a collegiate sporting event is taking place if the actor was not given effective notice under Section 30.06.

SECTION \_\_\_\_\_. Section 46.035(f), Penal Code, is amended by adding Subdivision (1-a) to read as follows:

(1-a) "Institution of higher education" and "private or independent institution of higher education" have the meanings assigned by Section 61.003, Education Code.

- (4) Renumber the SECTIONS of the bill accordingly.

(h) This section does not permit a person to possess a concealed handgun, or go with a concealed handgun, on a premises or other place on which a person or license holder is prohibited from carrying a handgun under Section 46.03 or 46.035, Penal Code, and that is located on the campus of an institution of higher education or private or independent institution of higher education.

The amendment to **CSSB 11** was read.

(2) In SECTION 1 of the bill, in added Section 411.2031(e), Government Code (page 1, line 51), strike "A" and substitute "An institution of higher education or".

(3) In SECTION 1 of the bill, in added Section 411.2031(e), Government Code (page 1, line 54), strike "prohibiting license holders from carrying" and substitute "allowing license holders to carry".

(8) In SECTION 3 of the bill, in amended Section 411.208(b), Government Code (page 2, lines 43-44), strike ", an officer or employee of an institution of higher education, a" and substitute "or".

(9) In SECTION 3 of the bill, in amended Section 411.208(b), Government Code (page 2, line 45), strike "not".

(10) In SECTION 3 of the bill, in amended Section 411.208(b), Government Code (page 2, line 47), strike "a" and substitute "an institution of higher education or".

(11) In SECTION 3 of the bill, in amended Section 411.208(b), Government Code (page 2, line 48), strike "not".

(12) In SECTION 3 of the bill, in added Section 411.208(d)(1), Government Code (page 2, lines 55-56), strike ", an officer or employee of an institution of higher education, a" and substitute "or".

(13) In SECTION 3 of the bill, in added Section 411.208(d)(1), Government Code (page 2, line 57), strike "not".

(14) In SECTION 3 of the bill, in added Section 411.208(d)(1), Government Code (page 2, line 58), strike "a" and substitute "an institution of higher education or".

(15) In SECTION 3 of the bill, in added Section 411.208(d)(1), Government Code (page 2, line 59), strike "not".

(16) In SECTION 4 of the bill, in amended Section 46.03(a)(1)(B), Penal Code (page 3, lines 24), between "education" and ";", insert "that has adopted rules under Section 411.2031(e), Government Code".

(2) In SECTION 3 of the bill, in amended Section 411.208(a), Government Code (page 2, lines 29-30), strike ", an officer or employee of an institution of higher education, a" and substitute "or".

(3) In SECTION 3 of the bill, in amended Section 411.208(a), Government Code (page 2, line 32), strike "a" and substitute "an institution of higher education or".

(4) In SECTION 3 of the bill, in amended Section 411.208(b), Government Code (page 2, lines 43-44), strike ", an officer or employee of an institution of higher education, a" and substitute "or".

(5) In SECTION 3 of the bill, in amended Section 411.208(b), Government Code (page 2, line 47), strike "a" and substitute "an institution of higher education or".

(6) In SECTION 3 of the bill, in added Section 411.208(d)(1), Government Code (page 2, lines 55-56), strike ", an officer or employee of an institution of higher education, a" and substitute "or".

(7) In SECTION 3 of the bill, in added Section 411.208(d)(1), Government Code (page 2, line 58), strike "a" and substitute "an institution of higher education or".

(8) Add the following appropriately numbered SECTION to the bill and renumber subsequent SECTIONS of the bill accordingly:

SECTION \_\_\_\_\_. Section 30.06(e), Penal Code, is amended to read as follows:

(e) It is an exception to the application of this section that the property on which the license holder carries a handgun is owned or leased by a governmental entity and is not:

(1) a premises or other place on which the license holder is prohibited from carrying the handgun under Section 46.03 or 46.035; or

(2) an institution of higher education that has adopted rules under Section 411.2031(e), Government Code.

The amendment to **CSSB 11** was read.

(1) In SECTION 1 of the bill, in added Section 411.2031(c), Government Code (page 1, line 40), strike "Except as provided by Subsection (d) or (e)," and substitute "Except as provided by Subsection (d), (d-1), or (e),".

(2) In SECTION 1 of the bill, in added Section 411.2031, Government Code (page 1, between lines 50 and 51), insert the following:

(d-1) An institution of higher education may establish rules, regulations, or other provisions prohibiting license holders from carrying handguns on premises that are owned or leased and operated by the institution and located on the campus of the institution only if a majority of the students at the institution vote to approve the rules, regulations, or other provisions.

(3) In SECTION 3 of the bill, in amended Section 411.208(a), Government Code (page 2, lines 28-30), strike "an institution of higher education, an officer or employee of an institution of higher education," and substitute "an institution of higher education that has not adopted rules under Section 411.2031(d-1), an officer or employee of an institution of higher education that has not adopted rules under Section 411.2031(d-1),".

(4) In SECTION 3 of the bill, in amended Section 411.208(b), Government Code (page 2, lines 43-44), strike "an institution of higher education, an officer or employee of an institution of higher education," and substitute "an institution of higher education that has not adopted rules under Section 411.2031(d-1), an officer or employee of an institution of higher education that has not adopted rules under Section 411.2031(d-1),".

Sec. 46.065. CERTAIN REQUIREMENTS RELATING TO SALES AT GUN SHOWS. (a) A person commits an offense if the person knowingly sells a firearm to another person in exchange for money or other consideration at a gun show without complying with the national instant criminal background check system in the manner required by 18 U.S.C. Section 922 before completing the sale. A person who conducts a criminal background check as required by this subsection may charge a fee of not more than \$10 to conduct the check.

(b) A person commits an offense if the person knowingly sells a firearm to another person in exchange for money or other consideration at a gun show and the person does not maintain a record of the sale.

(c) It is an exception to the application of Subsection (a) that the person to whom the firearm is sold:

(1) is licensed to carry a concealed handgun under Subchapter H, Chapter 411, Government Code; or

(2) is a peace officer.

(d) An offense under Subsection (a) or (b) is a Class A misdemeanor.

Sec. 46.066. CERTAIN REQUIREMENTS RELATING TO GUN SHOW PROMOTER. (a) A gun show promoter commits an offense if the promoter, with criminal negligence, permits the sale of a firearm to a person at a gun show organized, planned, promoted, or operated by the promoter without complying with the national instant criminal background check system in the manner required by 18 U.S.C. Section 922 before completion of the sale.

(b) It is an exception to the application of Subsection (a) that the person to whom the firearm is sold:

(1) is licensed to carry a concealed handgun under Subchapter H, Chapter 411, Government Code; or

(2) is a peace officer.

(c) Not later than the 30th day before the date on which a gun show is held, the gun show promoter shall provide written notice of the date, time, and place of the gun show to the local law enforcement agency of the county or, if applicable, the municipality in which the gun show will be held.

(d) A gun show promoter shall conduct, or arrange for a person who is a licensed firearms dealer under 18 U.S.C. Section 923 to conduct, an instant criminal background check in the manner required by 18 U.S.C. Section 922 on any person who purchases a firearm at a gun show organized, planned, promoted, or operated by the promoter from another person who is not a licensed firearms dealer under 18 U.S.C. Section 923. A person who conducts a criminal background check as required by this subsection may charge a fee of not more than \$10 to conduct the check.

(e) A gun show promoter shall prominently post a notice in a form prescribed by the Department of Public Safety stating the requirements under this section and Section 46.065 relating to an instant criminal background check.

(f) A gun show promoter commits an offense if the promoter violates Subsection (c), (d), or (e).

(g) An offense under Subsection (a) or (f) is a Class A misdemeanor.

(h) If conduct constituting an offense under this section also constitutes an offense under Section 46.065, the actor may be prosecuted under either section or under both sections.

SECTION \_\_\_\_\_. The change in law made by Section 46.066(c), Penal Code, as added by this Act, applies only to a gun show held on or after October 1, 2015.
