(Wednesday, February 8, 2017)

The Senate met at 11:00 a.m. pursuant to adjournment and was called to order by the President.

WHEREAS, Bobby Morrow was the leader of the American sprint team at the 1956 Summer Olympics; he gained global recognition at the event when he earned the gold medal in the 100-meter dash; he led the American sweep of medals in the

200-meter dash and earned his third gold medal by anchoring the 4x100-meter relay team to a world-record finish; in recognition of his accomplishments, *Sports Illustrated* named him the 1956 Sportsman of the Year; and

WHEREAS, Bobby Morrow is a revered Texan who has been honored for his numerous accomplishments; in October of 2006, San Benito High School named its new sports stadium in his honor, and in 2016, he was inducted into the Texas Track and Field Coaches Hall of Fame; now, therefore, be it

RESOLVED, That the Senate of the State of Texas, 85th Legislature, hereby commend Bobby Joe Morrow for his outstanding athletic career and congratulate him on being named the 2016 Texas Legend for the Eddie Lucio Scholarship Fund; and, be it further

**STATEMENT REGARDING SENATE BILL 4**

Senator Rodríguez submitted the following statement regarding **SB 4**:

Due to a medical emergency, I was unable to participate today when Senate Bill 4 passed on third reading. The following are statements I would have made on the Senate floor.

S.B. 4 places an unfair burden on local officials, including District and County Attorneys, Sheriffs, Police Chiefs, Mayors, and special district managers by requiring them to choose between their understanding of federal law – and in the case of El Paso, violating the terms of a federal settlement agreement – or violating state law.

S.B. 4 is not a community safety bill. In fact, S.B. 4 risks proven, lawful, and locally-determined public safety strategies. El Paso consistently ranks the safest city for its size in the U.S., a ranking due in large part to local law enforcement agencies that have fostered a trust-based relationship with the immigrant community. S.B. 4 hinders that relationship.

This is not unique to El Paso. Violent crime remains at historically low levels. This is particularly true in immigrant communities, which have a lower-than-average crime rate as compared to the overall rate in Texas.

There is another negative effect that is specific to my community. If enacted, S.B. 4 would severely penalize local governments by requiring that they forfeit all state grant funds for adopting policies that might be construed as prohibiting enforcement of federal immigration law.

In a settlement agreement entered in federal court in 2006, El Paso County agreed not to enforce federal immigration law. Under the court-entered agreement, El Paso County trains and supervises its deputies to enforce Texas criminal law, but not to detain or question victims, suspects, or witnesses regarding their immigration status. The author of the bill acknowledged that this puts El Paso County at risk of violating either the federal settlement agreement or state law, yet did not accept an amendment that would resolve the dilemma.

Furthermore, El Paso County, like every other county in Texas, is liable in federal court under 42 U.S.C. §1983, for each civil rights violation committed during police-citizen encounters. By burdening the officer on the street with decisions that they are not trained to make, this bill essentially makes every commissioned officer a policymaker and makes their respective jurisdictions legally responsible for every possible violation of federal law.

For these and other reasons, 1,142 of the 1,152 people who registered a position on S.B. 4 at the Senate State Affairs Committee hearing on Thursday, Feb. 2, were opposed, and so were 592 of the 606 who signed up to testify. From all walks of life, including students, business, labor, immigrants, legal experts, civil rights leaders, faith-based leaders, and law enforcement, they were resoundingly clear that the Texas Legislature should reject this legislation. I am proud to stand with them against the politics of fear.

S.B. 4 is not about public safety, it is about using the law to express distrust of immigrant communities, a theme that starts with the new presidential regime and is being conveyed by the Texas Legislature.

**SB 500**, Relating to the effect of certain felony convictions of public elected officers.

The bill was read second time.

Senator Zaffirini offered the following amendment to the bill:

**Floor Amendment No. 1**

Amend **SB 500** (senate committee printing) in SECTION 1 of the bill, in added Section 810.002(b)(2), Government Code (page 1, line 45), by striking "held" and substituting "was elected or appointed to".

The amendment to **SB 500** was read and was adopted by a viva voce vote.

SECTION 4. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2017.

(1) Add the following appropriately numbered SECTIONS to the bill:

SECTION \_\_\_\_\_. Article 42.01, Code of Criminal Procedure, is amended by adding Section 12 to read as follows:

Sec. 12. In addition to the information described by Section 1, the judgment should reflect affirmative findings entered pursuant to Article 42.0196.

SECTION \_\_\_\_\_. Chapter 42, Code of Criminal Procedure, is amended by adding Article 42.0196 to read as follows:

Art. 42.0196. FINDING REGARDING OFFENSE RELATED TO PERFORMANCE OF PUBLIC SERVICE. (a) In the trial of an offense described by Section 810.002, Government Code, the judge shall make an affirmative finding of fact and enter the affirmative finding in the judgment in the case if the judge determines that the defendant is:

(1) a member of the elected class described by Section 810.002(b)(1), Government Code, while a member of the Employees Retirement System of Texas; or

(2) a holder of an elected office for which the defendant wholly or partly became eligible for membership in a public retirement system.

(b) A judge who makes the affirmative finding described by this article shall make the determination and provide the notice required by Section 810.002(k), Government Code.

(2) In SECTION 1 of the bill, in added Section 810.002(d), Government Code (page 1, line 52), between "system" and "shall", insert ", on receipt of notice of a conviction under Subsection (e) or (k), any similar notice of a conviction of a qualifying felony from a United States district court or United States attorney, or any other information that the retirement system determines by rule is sufficient to establish a conviction of a qualifying felony,".

(3) In SECTION 1 of the bill, in added Section 810.002(d), Government Code (page 1, line 53), between "person" and "ineligible", insert "the system determines is".

(4) In SECTION 1 of the bill, following added Section 810.002(d), Government Code (page 2, between lines 1 and 2), insert the following:

(e) Not later than the 30th day after the conviction of a person of a qualifying felony, the governmental entity to which the person was elected or appointed must provide written notice of the conviction to the public retirement system in which the person is enrolled. The notice must comply with the administrative rules adopted by the public retirement system under Subsection (j).

(5) Reletter remaining subsections of added Section 810.002, Government Code, and cross-references to those subsections as necessary.

(6) In SECTION 1 of the bill, after added Section 810.002(i), Government Code (page 2, between lines 22 and 23), add the following:

(k) A court shall notify the retirement system of the terms of a conviction of a person convicted of an offense described by Subsection (c).

(7) Renumber subsequent SECTIONS of the bill accordingly.

**Floor Amendment No. 1**

Amend **SB 501** (Senate Committee printing) as follows:

(1) In SECTION 1 of the bill, strike added Subsection 572.023(b)(15)(C)(ii), Government Code (page 3, lines 1 through 4), and substitute the following:

(ii) a person who contracts with a governmental entity, if the individual or entity described by Paragraph (B) performs work arising out of the contract, subcontract, or agreement between the person and the governmental entity for a fee; and

SECTION \_\_. Subchapter B, Chapter 572, Government Code, is amended by adding Section 572.0295 to read as follows:

Sec. 572.0295. AMENDMENT OF FINANCIAL STATEMENT. (a) A person who files a financial statement under this chapter may amend the person's statement.

(b) A financial statement that is amended is considered to have been filed on the date on which the original statement was filed if:

(1) the amendment is made on or before the 14th day after the date the person filing the statement learns of an error or omission in the original statement;

(2) the original financial statement was made in good faith and without an intent to mislead or to misrepresent the information contained in the statement; and

(3) the person filing the amendment accompanies the amendment with a declaration that:

(A) the person became aware of the error or omission in the original statement during the preceding 14 days; and

(B) the original statement was made in good faith and without intent to mislead or to misrepresent the information contained in the statement.

(a) This section applies only to a referral made to or received from a person if during the period covered by the financial statement the total amount of compensation for all referrals made to or received from that person exceeds \$2,500.
