The Senate met at 11:00 a.m. pursuant to adjournment and was called to order by the President.

Senator Menéndez offered the following resolution:

WHEREAS, Proud residents of the Alamo City are visiting Austin on February 28, 2017, to celebrate VIVA San Antonio Day at the State Capitol; and

WHEREAS, The history of San Antonio can be traced back to 1691, when a group of Spanish explorers and missionaries came upon a river and named it San Antonio, in honor of Saint Anthony, whose feast day was being celebrated; and

WHEREAS, The city was founded in 1718 by Father Antonio Olivares; he established Mission San Antonio de Valero, which would become etched in the annals of history in 1836 as the Alamo, the site where 189 brave individuals held the mission for 13 days against an army of some 4,000 Mexican soldiers; the cry "Remember the Alamo" became the rallying point of the Texas Revolution; today, the Alamo is a shrine and museum and is widely recognized as the cradle of Texas liberty; and

WHEREAS, San Antonio became formally incorporated in 1837, when the fledgling Republic of Texas granted the city a charter; the community has since retained its sense of history and tradition while carefully blending in cosmopolitan progress; it continues to serve as a crossroads and a meeting place, where the rich cultural influences of Native Americans, Old Mexico, German immigrants, the Wild West, African Americans, and the Deep South mingle and merge; and

WHEREAS, The city has a proud military heritage; great military figures like Pershing, Stilwell, Krueger, LeMay, Chennault, and Eisenhower served at San Antonio military institutions, including Fort Sam Houston, the headquarters for the U.S. Army North and U.S. Army South, and Randolph Air Force Base, the home of Air Education and Training Command; in addition, San Antonio is the site of Lackland Air Force Base, the largest training wing in the United States Air Force, and the San Antonio Military Health System, home of all U.S. military medical training; and

WHEREAS, Recent years have brought remarkable economic development to San Antonio as its skilled workforce, excellent institutions of public and higher education, and high quality of life have attracted important corporate businesses and industries to the city; and

WHEREAS, The city's chambers of commerce serve as leading advocates for the business community and are dedicated to building and sustaining San Antonio's diverse and prosperous economy, particularly in the major local industries of health care, manufacturing, aerospace, information technology, and cybersecurity; and

WHEREAS, Millions of visitors a year delight in visiting San Antonio; in addition to the Alamo, highlights include La Villita, San Fernando Cathedral, the San Antonio Missions Trail, and the famed Paseo del Rio, also known as The Riverwalk; among the other attractions that make San Antonio one of the top tourist destinations in the country are SeaWorld San Antonio and the Six Flags Fiesta Texas theme park as well as the PGA Tour Valero Texas Open, the Alamo Bowl, and the five-time world champion San Antonio Spurs; and

WHEREAS, In April 2017, the city will once again celebrate Fiesta San Antonio, the biggest 11-day party in the state; first held more than 120 years ago, the event was founded by a group of women who decorated horse-drawn carriages for a parade in front of the Alamo and battled with flower blossoms instead of bullets to honor the heroes of the Alamo and the Battle of San Jacinto; and

WHEREAS, San Antonio is truly one of the treasures of the Lone Star State, and VIVA San Antonio Day provides a welcome opportunity to honor the city and its many fine residents; now, therefore, be it

RESOLVED, That the Senate of the 85th Texas Legislature hereby recognize February 28, 2017, as VIVA San Antonio Day at the State Capitol and extend to the visiting delegation sincere best wishes for an informative and enjoyable stay in Austin.

SENATE BILL 44 ON SECOND READING

On motion of Senator Zaffirini and by unanimous consent, Senate Rule 7.13; Section 5, Article III of the Texas Constitution; and the regular order of business were suspended to take up for consideration **SB 44** at this time:

SB 44, Relating to petition requirements for an application for a place on the general primary election ballot for certain judicial offices.

The bill was read second time and was passed to engrossment by a viva voce vote.

All Members are deemed to have voted "Yea" on the passage to engrossment.

SENATE JOINT RESOLUTION 38 ON SECOND READING

Amend **SJR 38** (senate committee report), on page 1, between lines 43 and 44, by inserting the following:

RESOLVED, That the 85th Legislature of the State of Texas, Regular Session, 2017, hereby declares that any application to the United States Congress for the calling of a convention under Article V of the United States Constitution that is submitted by the Texas Legislature during or after this Regular Session shall be automatically rescinded, repealed, revoked, canceled, voided, and nullified if the applicable convention is not called on or before the 12th anniversary of the date the last legislative vote is taken on the application; and, be it further

Amend **SB 21** (senate committee report) in SECTION 1 of the bill, in added Subchapter B, Chapter 393, Government Code, by adding a new appropriately numbered section after added Section 393.055 (page 3, between lines 11 and 12) to read as follows:

Sec. 393._____. PROHIBITION ON ACCEPTANCE OF BENEFIT. A delegate or alternate delegate may not accept a gift, a loan, food or beverages, entertainment, lodging, transportation, or another benefit from a person, including a corporation, nonprofit organization, or individual, if that person is required to register as a lobbyist under Chapter 305 or under other law.

- (1) In added Section 393.103(b), Government Code (page 3, line 32), following "unauthorized vote", insert "for purposes of this section".
- (2) At the end of added Subchapter C, Chapter 393, Government Code (page 3, between lines 47 and 48), insert the following appropriately numbered section:
- Sec. 393. ____. CRIMINAL PENALTY. (a) A delegate or alternate delegate commits an offense if the delegate or alternate delegate knowingly casts an unauthorized vote.
 - (b) An offense under this section is a state jail felony.
- (c) A judge granting community supervision to a defendant convicted of an offense under this section shall require as a condition of community supervision that the defendant submit to not less than 10 days of confinement in county jail. If a sentence of confinement is imposed on the revocation of community supervision, the term of confinement served under this subsection may not be credited toward completion of the sentence imposed.

Sec. 393.104. OVERSIGHT COMMITTEE. (a) The legislature shall appoint an Article V Oversight Committee at the time delegates and alternate delegates are appointed under Section 393.051.

- (b) The committee consists of the following 10 members:
 - (1) the lieutenant governor;
 - (2) the speaker of the house of representatives;
 - (3) the chair of the senate state affairs committee;
 - (4) the chair of the house state affairs committee;
 - (5) three members of the senate appointed by the lieutenant governor; and
- (6) three members of the house of representatives appointed by the speaker of the house of representatives.
- (c) The lieutenant governor and the speaker of the house of representatives are joint chairs of the committee.
- (d) If the legislature is not convened in regular or special session at any time during which an Article V convention is convened, the members of the committee shall:
 - (1) meet at the call of either joint chair at the State Capitol; and
- (2) determine whether a vote cast by a delegate or alternate delegate is an unauthorized vote for the purposes of Section 393.103.
- (e) A vote cast by a delegate or alternate delegate is an unauthorized vote for the purposes of Section 393.103 if five or more members of the committee determine by committee vote that the vote cast was an unauthorized vote.
- (f) The committee is not authorized to take any action when the legislature is convened in regular or special session.

- (4) On page 2, line 8, between "Congress for a" and "convention", insert "public".
 - (5) On page 2, line 17, immediately after "Congress for a", insert "public".
