TWENTY-EIGHTH DAY

(Tuesday, March 26, 2019)

The Senate met at 11:00 a.m. pursuant to adjournment and was called to order by the President.

SENATE RESOLUTION 479

Senator Rodríguez offered the following resolution:

WHEREAS, *BlackKlansman*, an award-winning movie that most recently was honored with an Oscar, tells the story of an investigation into the Ku Klux Klan that was conducted by Ron Stallworth, a black police officer who was born and raised in El Paso, Texas; and

WHEREAS, Mr. Stallworth was hired as a police cadet in Colorado Springs and eventually promoted to police officer, and he became the first black detective in the history of the Colorado Springs Police Department; and

WHEREAS, In 1979, he responded to a classified advertisement recruiting Klan members, and when he was asked to join the cause, his department agreed to begin an undercover investigation into Klan activities, during the course of which he established a relationship with national Klan leader David Duke; and

WHEREAS, The investigation, conducted over the phone by Mr. Stallworth and in person by a white detective posing as him, resulted in a curtailing of local Klan activities, such as cross-burnings; and

WHEREAS, Mr. Stallworth left Colorado Springs in 1980, and he was subsequently employed in law enforcement agencies in Arizona and Wyoming, and in Utah, where he worked at the Department of Public Safety on gang issues; and

WHEREAS, Mr. Stallworth moved back to El Paso after retiring, and in 2013, he wrote the book *Black Klansman*, which was informed in part by his conviction that while our country had made much progress in eradicating the influence of racism, there is still much work to be done; and

WHEREAS, Growing up in El Paso, Mr. Stallworth was part of a small but proud black community with a strong history of civil rights advocacy; El Paso and its citizens have for many years played a leading role in the dismantling of widespread practices of segregation, from the lawsuits that led to the ending of all-white primary elections to the desegregation of schools, colleges, public accommodations, and sports teams; and

WHEREAS, Despite these achievements, many people in El Paso still remember segregated public accommodations and a struggle for voting rights and for representation of Hispanics in elected and economic leadership positions; and

WHEREAS, *Black Klansman* is both an exceptional movie and a stirring reminder that our society must never stop progressing toward greater equality and understanding; Ron Stallworth exemplifies his El Paso roots and with his book and the film has told a compelling story of significant import; now, therefore, be it

RESOLVED, That the Senate of the State of Texas, 86th Legislature, hereby commend Ron Stallworth for his efforts to advance the progress of and the conversation around civil rights and racial equality in our society and extend to him congratulations on the success of his book *Black Klansman* and its adaptation as a movie and on the widespread impact of its message.

(D) potential witnesses to the incident as necessary to conduct an investigation of the report

SENATE BILL 632 ON SECOND READING**

CSSB 632, Relating to the composition of the governing bodies and the consultation policies of local mental health authorities with respect to sheriffs, their representatives, and local law enforcement agencies.

Senator Kolkhorst offered the following amendment to the bill:

Floor Amendment No. 1

Amend **CSSB 632** (senate committee report) as follows:

(1) In SECTION 1 of the bill, in added Section 533.0351, Health and Safety Code (page 1, between lines 47 and 48), add the following appropriately lettered subsection:

() This section does not prevent a sheriff or representative of a sheriff from being included in the governing body of a local mental health authority as a voting member of the body.

(2) In SECTION 3 of the bill, in amended Section 534.002, Health and Safety Code (page 2, between lines 36 and 37), add the following appropriately lettered subsection:

() Subsection (a)(3) does not prevent a sheriff or representative of a sheriff from being included on the board of trustees of a community center as a voting member of the board.

(3) In SECTION 4 of the bill, in the recital (page 2, line 38), strike "Subsection (a-1)" and substitute "Subsections (a-1) and (a-2)".

(4) In SECTION 4 of the bill, in amended Section 534.003, Health and Safety Code (page 2, between lines 54 and 55), add the following subsection:

(a-2) Subsection (a-1) does not prevent a sheriff or representative of a sheriff from being included on the board of trustees of a community center as a voting member of the board.

(5) Add the following appropriately numbered SECTION to the bill and renumber subsequent SECTIONS of the bill accordingly:

SECTION _____. If the governing body of a local mental health authority established under Chapter 533, Health and Safety Code, or the board of trustees of a community center established under Chapter 534, Health and Safety Code, includes a sheriff or representative of a sheriff as a voting member of the governing body or board of trustees before the effective date of this Act, the sheriff or representative of the sheriff may continue to serve as a voting member of the governing body or board of trustees after the effective date of this Act.

The amendment to **CSSB 632** was read and was adopted by a viva voce vote.

SB 449, Relating to testimony by an appraisal district employee as to the value of real property in certain ad valorem tax appeals.

The bill was read second time and was passed to engrossment by a viva voce vote.

All Members are deemed to have voted "Yea" on the passage to engrossment.

On motion of Senator Lucio and by unanimous consent, the remarks by Senator Watson regarding Sharon Young were ordered reduced to writing and printed in the *Senate Journal* as follows:

Thank you, Mr. President, and thank you, Dean. Members, I'm going to move today that we adjourn in honor of Sharon Young. Sharon Young passed away last Thursday, and Ms. Young, it feels a little weird for me, frankly, to call her Sharon Young, because I always knew her as Ms. Young, and Ms. Young was one of my teachers in high school. She was a teacher who taught for 45 years at the Eagle Mountain-Saginaw Independent School District up in the Fort Worth area. She began teaching at Boswell High School in 1968 and spent her entire career there as an educator in business and career preparation classes. She retired in 2013, but upon her retirement she really couldn't stay away from teaching, so she also served as a substitute teacher many, many times and was at the campus all of the time on different events that were going on. She was a skillful teacher. She was a wise counsel. She was very pragmatic in the way she approached things. She also was involved in efforts in the community to raise scholarship money for the, so that students could go on and continue their education. And she always worked to help place her students in jobs after they had finished being her students. Actually, you never ended being Ms. Young's student, if I stop and think about it. I was fortunate enough to have Ms. Young as a teacher. Chair Nelson, she taught me bookkeeping, which I think may be my qualification to be on the Finance Committee. But in addition to that, I had a special opportunity because she was junior class president the year, I mean junior class sponsor, the year I was class president, and we organized the Junior-Senior Prom that year for 1975. What that meant was that I got to have special moments with Ms. Young. Members, she was a happy, enthusiastic person who embraced joy. When you were with her, you just, there was this electricity about her that made you feel good, made you feel happy. She worked very hard at seeking out the strength in her students. And in whatever they might be doing, whatever they were, they were charging forward to take care of, she motivated them by being so very, very positive. And that positive outlook, I

will tell you from personal experience, helped you avoid frustration, it helped you avoid stress, it helped you enjoy life and school much more. She really created success in her students through her constant encouragement. It's been an interesting couple of weeks, or several weeks, because she got sick, we were told she was sick, and it went real fast. And during that, the moment I found out that she was sick, which just seemed impossible, knowing her the way I had and the way we all had, one of the first things I remembered was how special she made me feel as a student. And I realized that I had carried that feeling over 40 years later. Ms. Young still made me feel special. But something beautiful happened during this period of time where she was sick. With Facebook and texting and things like that, people from Boswell were able to connect with each other again because of Ms. Young. And what became so apparent is that wonderful warm feeling that I've had for 40 years about Sharon Young, about how special she made me feel. It was clear that she made everybody feel that way. She made everyone feel like they were something special and important to her. She, I will tell you, she brought us all together again in our sadness, of course, because we've lost somebody that means so much to us, but more, really in our shared connection to her, in our memories of what a wonderful person she was and of that tremendous, tremendous smile. Who knows how many lives this sweet, dear person touched? Loved us, she nurtured us, she helped raise us, and she is today a part of each of us because she was our teacher. And here we are in this session where I am so pleased it's a session where we're working hard to recognize the value of those who teach. Ms. Young exemplified why we should be doing that and why we should value them. So, thanks to those who take up this wonderful profession as teachers and thanks, Ms. Young.

WHEREAS, Mrs. Jackson received her bachelor of business administration degree in management from The University of Texas of the Permian Basin in 1981, and she fulfilled all the requirements for her degree while working full-time as an enforcement officer; and

WHEREAS, In 1982, she was initiated into Alpha Kappa Alpha Sorority, Incorporated, Rho Iota Chapter, and she later was honored as a Silver Soror; and

WHEREAS, She completed the Graduate School of Business Governor's Executive Development Program at The University of Texas Lyndon B. Johnson School of Public Affairs in 1992; and

WHEREAS, Dovie received the Distinguished Former Odessan award in 1998 from the Heritage of Odessa Foundation, and The University of Texas of the Permian Basin Alumni Association honored Mrs. Jackson as its 2006 Distinguished Alumnus for her professional achievements and loyal service to the university; and

WHEREAS, She was a longtime member of Mount Zion Baptist Church in Austin and served as a member of the church's board of trustees, finance committee, and building committee; and

WHEREAS, Mrs. Jackson was President Emeritus of Black American Comptroller Employees, and she was the first African American and first woman to be named Deputy Comptroller for the State of Texas; and

WHEREAS, She was the first director of the Comptroller's Employee Engagement Division, and she served as a mentor to the agency's next generation of employees; she worked across the agency to make the workplace better for all; and
