In honor of the memory of Teresa Lozano Long, the text of the resolution is printed at the end of today's *Senate Journal*.

### REMARKS ORDERED PRINTED

On motion of Senator Menéndez and by unanimous consent, the remarks by Senators Zaffirini, Eckhardt, and Menéndez regarding **SR 187** were ordered reduced to writing and printed in the *Senate Journal* as follows:

**Senator Zaffirini:** Thank you, Mr. President. Mr. President and Members, if you read the *Austin American-Statesman* today, you saw this beautiful article with a headline, "UT's Mother Teresa Built Life Around Giving" and that was the legacy of Dr. Teresa Lozano Long. The beautiful, brilliant, and beloved Dr. Teresa Altagracia Lozano Long was a dairy farmer's daughter from Premont who became a legend in her own time. Altagracia translates literally into high grace or very gracious, so

gracious really was her maiden name. Known as UT's Mother Teresa, she was as kind and as lovely as she was fierce and focused on creating a better future, especially for low-income Mexican Americans through education and through the arts. In 1945, Terry took her first step as a Texas trailblazer as the first Mexican American high school valedictorian in Premont. She accepted an unsolicited \$50 scholarship, \$25 a semester, from UT Austin. That year the petite 16-year-old was the only Mexican American and the only female in her major department, physical education. Soon she became the first Mexican American woman to earn bachelor's, master's, and doctoral degrees in PE from UT, though between graduate degrees, she moved to Alice. She was teaching junior high PE and Joe was teaching high school civics there when they met and fell madly in love at a time when inter-ethnic relationships were not only rare, but also controversial. They married and lived happily ever after as a unifying force for good, a motivating model of selfless service and an inspiring paragon of mutual loyalty and devotion. They were inseparable. Equally joyfully, Terry and Joe contributed more than \$150 million to nonprofits and to education. Terry Long was loved so very much because she was so loving, and she was as much a blessing in the lives of those she loved as they were in hers. She was happy about so many things, but most especially about the accomplishments of young scholars at the Dr. Teresa Lozano Long Institute of Latin American Studies at UT Austin and the Joe R. and Teresa Lozano Long School of Medicine at the UT Health Science Center at San Antonio. It was my pleasure to introduce Terry many times as she and Joe received multiple awards from a rich variety of groups including Texas Exes, Caritas, and Mental Health America of Texas. Dr. Teresa Lozano Long was a true Texas treasure, an icon who will be missed. Her impact, however, will increase over time as generations will benefit from her gifts to society. Our communities and our state are better because she lived. Thank you, Mr. President and Members. It is my pleasure to yield to Senator Eckhardt.

**President:** Thank you, Senator. Senator Eckhardt, you're recognized.

**Senator Eckhardt:** I did not have the honor of being on a first-name basis with Dr. Long as Senator Zaffirini was, but her reputation is all over the city and all over this state. Truly, *altagracia* is an appropriate term, high grace, and Dr. Long had a life that represented high grace. If any of you all have been in the lovely room at the top of the Long Center for any kind of event, that room should be the Room of High Grace named for Dr. Long, and I will talk to them about renaming it such. Dr. Long represented what it means to pay it forward, what it means to leave this state better than you found it, what it means to build opportunity infrastructure, not just for you, not just for your family, but families into the future that you will never know, families into the future that may have nothing to do with you, but everything to do with opportunity for every Texan for generations to come. So, thank you very much for this resolution, and I joyfully join you in it.

**President:** Senator Menéndez, you're recognized on the resolution.

**Senator Menéndez:** Thank you, Mr. President. First, I'd like to make a motion to reduce to writing the comments on Resolution 187 and put them in the Journal, if that's appropriate.

**President:** It's very appropriate. Any objection? Hearing none, motion is adopted.

**Senator Menéndez:** I'd also like to thank our friend and colleague, Senator Zaffirini and Senator Eckhardt for bringing this forward. I had the privilege of getting to know or meet Dr. Teresa Altagracia Lozano Long and Joe. And you know, you've said it all, but I just want to reaffirm that she dedicated her life to service. Her commitment to higher education, continuous generosity opened the door for countless students to pursue education in the State of Texas. And, you know, their record for their philanthropic roles in this state are renowned. But what I love is that their strong marriage, their bond, their love that lasted 60-plus years and the happiness that they took in helping others. And so many times it's, you know, it is not always that people who have great success look back and look for ways to help others. And not only did they help in the medical school in San Antonio that you mentioned, which is going to provide so many more access to medical services in South Texas, nursing school that's there, the dental school, but also their endowment of the Teresa Lozano Long Institute of Latin American Studies. And because of their gift, UT Austin is now a flagship in Latin American studies, and students from across the state and the nation will have an opportunity to enroll in that department and to learn more about their heritage. And I just believe and know for a fact that through their foundation and the permanent fund set up for scholarships that it's going to just help so many students who might otherwise not be able to attend college, be able to be there. So, it is very appropriate that when you recognize whose lifelong contributions will be embedded in our state for generations to come. Her dedication to service, to students, and particularly to Hispanic students will be forever present in this state and her spirit should be an example to all of us, so thank you very much for bringing this forward. It is an honor to be able to speak on this resolution. Thank you, Mr. President.

**President:** Thank you, Senator. Senator Zaffirini to close.

**Senator Zaffirini:** Thank you, Mr. President. Mr. President and Members, every time I introduced Joe and Terry for one of their multiple awards, I always interviewed them, because I always wanted the most recent facts about their accomplishments. And one time I asked them, do you have any regrets, and this is what they agreed. They regretted that they didn't have more money so they would have more money to give away. Isn't that incredible? Mr. President, I move adoption, Senate Resolution 187.

WHEREAS, The Senate of the State of Texas honors and commemorates the life of Teresa Altagracia Lozano Long, beloved wife, friend, patron of the arts, champion of education, and philanthropist, who died March 22, 2021, at the age of 92; and

WHEREAS, "Altagracia" translates as "High Grace" or "Very Gracious," a reflection of Teresa's remarkable kindness, compassion, and commitment to improving the lives of low-income Texans; and

WHEREAS, Teresa Lozano Long was born in Premont on July 20, 1928, to Arturo V. and Elvira D. Lozano, and immediately began blazing trails: She was Premont High School's first Mexican American valedictorian at the age of 16 before enrolling at The University of Texas at Austin, at which she was the only female and the only Mexican American student majoring in physical education; and

WHEREAS, While teaching junior high in Alice, Texas, she met Joe Long, at a time when intercultural relationships were not only rare, but also controversial, and after marrying on February 1, 1958, they were blessed with more than six happy and harmonious decades together; and

WHEREAS, Teresa and Joe shone together as ardent advocates of education and the arts who basked in the joy of providing scholarships for students and who became significant contributors in myriad fields including medicine, teaching, and the fine and performing arts; and

WHEREAS, She blossomed professionally as a Consultant for the U.S. Office of Education on Migrant Education and Head Start Program and in the Review Section of the Division of Compensatory Education of the Texas Education Agency, where she also worked as a Research Assistant, and as a Research Associate for the Governor's Committee on Public School Education; and

WHEREAS, Her civic leadership was evident through the countless boards and councils on which she served, including the Chancellor's Council and Development Board at The University of Texas, Texas Committee for National Museum of Women in the Arts, National Council on the Arts, Austin College, First State Bank and Community National Bank, Austin Lyric Opera, St. Austin Catholic School, Seton Medical Center Auxiliary, Laguna Gloria Museum, and Ballet Austin; and

WHEREAS, Her legacy of service forever will be memorialized in the Dr. Teresa Lozano Long Institute of Latin American Studies at The University of Texas at Austin, the Joe R. and Teresa Lozano Long School of

Medicine at The University of Texas Health Science Center at San Antonio, and the Joe R. and Teresa Lozano Long Center for the Performing Arts in Austin; and

WHEREAS, She received countless awards and honors for her civic and philanthropic work, including being named a Distinguished Alumna of The University of Texas at Austin, a member of the Texas Women's Hall of Fame, and a recipient of the National Humanities Medal; and

WHEREAS, She and her husband will impact generations of Texans, past, present, and future, through the more than \$150 million they have contributed to nonprofits and higher education, mostly for scholarships and programs; and

WHEREAS, She is survived not only by her beloved husband, but also by her brother, Hector Lozano; her honorary grandchildren, Gael, Alan, and Aranza—children of Ulises and Betty Perez; her many nieces, nephews, cousins, and dear friends; and she will be best remembered by those who know her as a devoted wife; a beloved friend; and an avid believer in the transformational power of education; now, therefore, be it

RESOLVED, That the Senate of the State of Texas, 87th Legislature, hereby extend sincere condolences to the bereaved family of Teresa Lozano Long; and, be it further
