## SENATE BILL 2 ON SECOND READING

Senator Birdwell moved to suspend the regular order of business and Senate Rule 7.12(a) to take up for consideration **SB 2** at this time on its second reading:

**SB 2**, Relating to the creation of the criminal offense of improper entry from a foreign nation.

#### Floor Amendment No. 1

Amend SB 2 (senate committee printing) as follows:

- (1) In SECTION 1 of the bill, immediately following added Section 38.20(c), Penal Code (page 1, between lines 41 and 42), insert the following appropriately lettered subsection and reletter subsequent subsections and references to those subsections accordingly:
- (\_\_\_) It is a defense to prosecution under this section that the actor was coerced to commit the offense by a peace officer in violation of Section 39.08.
- (2) Add the following appropriately numbered SECTION to the bill and renumber subsequent SECTIONS of the bill accordingly:

SECTION \_\_\_\_\_. Chapter 39, Penal Code, is amended by adding Section 39.08 to read as follows:

Sec. 39.08. COERCION TO COMMIT IMPROPER ENTRY FROM FOREIGN NATION. (a) A person who is a peace officer commits an offense if the person knowingly coerces a person to engage in conduct constituting an offense under Section 38.20(b).

(b) An offense under this section is a Class A misdemeanor.

#### SENATE BILL 8 ON SECOND READING

**SB 8**, Relating to measures to address public safety threats in this state presented by transnational criminal activity, including by establishing a Texas Border Force and making funds available to certain governmental entities.

#### Floor Amendment No. 1

Amend **SB 8** (senate committee report) as follows:

- (1) In SECTION 1.02 of the bill, in the heading to added Section 411.0287, Government Code (page 2, line 65), between "TRAINING" and the underlined period, insert "REQUIRED".
- (2) In SECTION 1.02 of the bill, immediately after added Section 411.0287, Government Code (page 3, between lines 5 and 6), insert the following:
- (c) Any officer or employee who performs duties in connection with a border security operation of the border force shall complete a training on federal immigration law with respect to a person's right to seek asylum and appropriate procedures for affording a person that right.

Amend **SB 8** (senate committee report) in SECTION 1.02 of the bill, immediately after added Section 411.0289, Government Code (page 3, between lines 14 and 15), by inserting the following:

Sec. 411.0290. INTERPRETER SERVICES REQUIRED FOR BORDER SECURITY OPERATIONS. The border force shall ensure that interpreter services are available to officers and employees of the border force during any border security operation, including during the apprehension of a person suspected of violating 8 U.S.C. Section 1325(a). The border force may employ interpreters or contract for interpreter services as necessary to ensure immediate availability of the services during a border security operation.

ARTICLE \_\_\_\_. COMPLIANCE WITH FEDERAL IMMIGRATION LAW BY LOCAL GOVERNMENT

SECTION \_\_\_\_. Chapter 752, Government Code, is amended by adding Subchapter D to read as follows:

# SUBCHAPTER D. COMPLIANCE WITH FEDERAL IMMIGRATION LAW BY LOCAL GOVERNMENT

Sec. 752.081. AUTHORITY TO COMPLY. (a) In this section, "local government" means a municipality, county, special purpose district, or any other political subdivision of this state.

(b) Notwithstanding any other law, a local government may comply with federal immigration law, regardless of whether a state officer is directing the local government to act otherwise.
