**SENATE RESOLUTION 414**

Senator Flores offered the following resolution:

WHEREAS, Legendary country music singer and songwriter Tanya Tucker is visiting the State Capitol on April 13, 2023, providing a welcome opportunity to pay tribute to her many achievements; and

WHEREAS, A native of Seminole, Tanya Tucker began showcasing her vocal talents from a young age, and after signing to Columbia Records, she scored her first hit in 1972 with "Delta Dawn" at the age of 13; that year, she made her debut at the Grand Ole Opry and was named the New Female Vocalist of the Year by the Academy of Country Music; her second album spawned two No. 1 songs, "What's Your Mama's Name" and "Blood Red and Goin' Down" and established her as a major star; her run of country hits included "Lizzie and the Rainman," "San Antonio Stroll," and "Don't Believe My Heart Can Stand Another You" in 1975, and she followed that up with the albums *Lovin' and Learnin'* and *Here's Some Love* in 1976 and *Ridin' Rainbows* in 1977; and

WHEREAS, Ms. Tucker moved to Los Angeles in 1978 and ventured into new territory with *T.N.T.*, an album that achieved gold certification and earned her a Grammy nomination for best rock vocal performance; in the subsequent years, she appeared on several television shows and made her feature film debut in *Hard Country*; over the course of her career, she has earned additional credits on *The Rebels* miniseries, *Love Boat*, and *Touched by an Angel* in addition to appearing on *American Idol* and countless other programs; and

WHEREAS, Beginning with *Girls Like Me* in 1986, Ms. Tucker enjoyed one of the most successful stretches of her career, racking up four top-10 country singles on that album and eight top-10 singles in a row between 1988 and 1989; she was selected as the Female Vocalist of the Year in 1991 by the Country Music Association, and in 1994, she performed at the halftime show of Super Bowl XXVIII with Clint Black, Travis Tritt, and Wynonna Judd; in 1997, she returned to the top 10 with the hit, "Little Things," and was inducted into the Texas Country Music Hall of Fame; and

WHEREAS, Since 2000, Ms. Tucker has established her own label, Tuckertime Records, authored a book, *100 Ways to Beat the Blues on Fireside*, and continued to perform and release new albums; she received her first two Grammy Awards in 2020 for "While I'm Livin'" and "Bring My Flowers Now," and the Country Music Hall of Fame announced that she would be inducted as a member of the Class of 2023; and

WHEREAS, With her iconic voice and spirited live performances, Tanya Tucker has won the enduring affection of generations of country music fans, and her outstanding accomplishments are a source of tremendous pride to her fellow Texans; now, therefore, be it

RESOLVED, That the Senate of the 88th Texas Legislature hereby honor Tanya Tucker for her contributions to music and extend to her sincere best wishes for continued success; and, be it further

RESOLVED, That an official copy of this resolution be prepared for Ms. Tucker as an expression of high regard by the Texas Senate.

Question: Shall **CSSB 13** be passed to engrossment?

#### Floor Amendment No. 1

Amend **CSSB 13** (senate committee report) as follows:

(1) In SECTION 5 of the bill, in added Section 33.026(c), Education Code (page 2, line 61), strike "procurement" and substitute "acquisition".

(2) In SECTION 5 of the bill, in the heading to added Section 33.027, Education Code (page 3, line 51), strike "PROCUREMENT" and substitute "ACQUISITION".

(3) In SECTION 5 of the bill, in added Section 33.027(a), Education Code (page 3, line 53), strike "procurement of library materials" and substitute "acquisition of library materials, including procedures for the procurement of library materials and the receipt of donated library materials".

(4) In SECTION 5 of the bill, in added Section 33.027(a)(1), Education Code (page 3, line 55), between "materials" and "to" insert "that have been donated to or that are".

(5) In SECTION 5 of the bill, in added Section 33.027(a), Education Code (page 3, lines 59-60 and 63), strike "proposed to be procured" in each instance that it appears and substitute "that have been donated to or that are proposed to be procured by a school library".

(6) In SECTION 5 of the bill, in added Section 33.027(b), Education Code (page 3, lines 68-69), strike "proposed to be procured for a school library" and substitute "that have been donated to or that are proposed to be procured by a school library".

(7) In SECTION 5 of the bill, in added Section 33.027, Education Code (page 4, between lines 3 and 4), add the following appropriately lettered subsection and reletter subsequent subsections and cross-references to those subsections accordingly:

( ) A school district may not add a donated library material to the school library catalog or otherwise make the donated library material available for student use unless the board of trustees of the district approves the addition of that donated library material to the school library catalog for the grade levels for which the material is intended.

(8) In SECTION 5 of the bill, in added Section 33.027(c), Education Code (page 4, line 4), between "materials" and "to" insert "that have been donated to or that are".

(9) In SECTION 5 of the bill, in added Section 33.027(c), Education Code (page 4, lines 10 through 12), strike added Subdivision (3) and substitute the following:

(3) have been approved for the same grade levels by the board of trustees of the school district from a previous proposed list of library materials.

(10) In SECTION 7 of the bill, in the transition language (page 5, line 9), strike "procurement" and substitute "acquisition".

The amendment to **CSSB 13** was read and was adopted by a viva voce vote.

(g) The county clerk or other authority conducting an election may challenge a determination under this section by the secretary of state that a violation of this code has occurred in the appropriate district court not later than the 30th day after the date the clerk or other authority receives a notice under Section 280.003(a). Sovereign immunity is waived for purposes of a challenge under this subsection.

(2) In SECTION 1 of the bill, in added Section 280.003(b), Election Code (page 2, line 51), immediately following "notice", insert "or the date the county clerk's or other authority's action under Section 280.002(g) is brought to final disposition, whichever is later".

"(3) two members who are building contractors principally engaged in home construction and who are members of a statewide building trade association;".

(3) In SECTION 2 of the bill, in added Section 1958.031(a), Occupations Code (page 1, between lines 47 and 48), insert the following appropriately numbered subdivision and renumber the subdivisions of added Section 1958.031(a), Occupations Code, and cross-references to those subdivisions accordingly:

"( ) one member who is a representative of the insurance industry;".

(4) In SECTION 2 of the bill, in added Section 1958.032, Occupations Code (page 1, line 59), strike "three" and substitute "three or four".

(5) In SECTION 4 of the bill, in the transition language (page 2), strike lines 28 through 31 and substitute "designate three members of the advisory board to serve terms expiring February 1, 2025, four members to serve terms expiring February 1, 2027, and four members to serve terms expiring February 1, 2029."

The amendment to **CSSB 1213** was read and was adopted by a viva voce vote.
